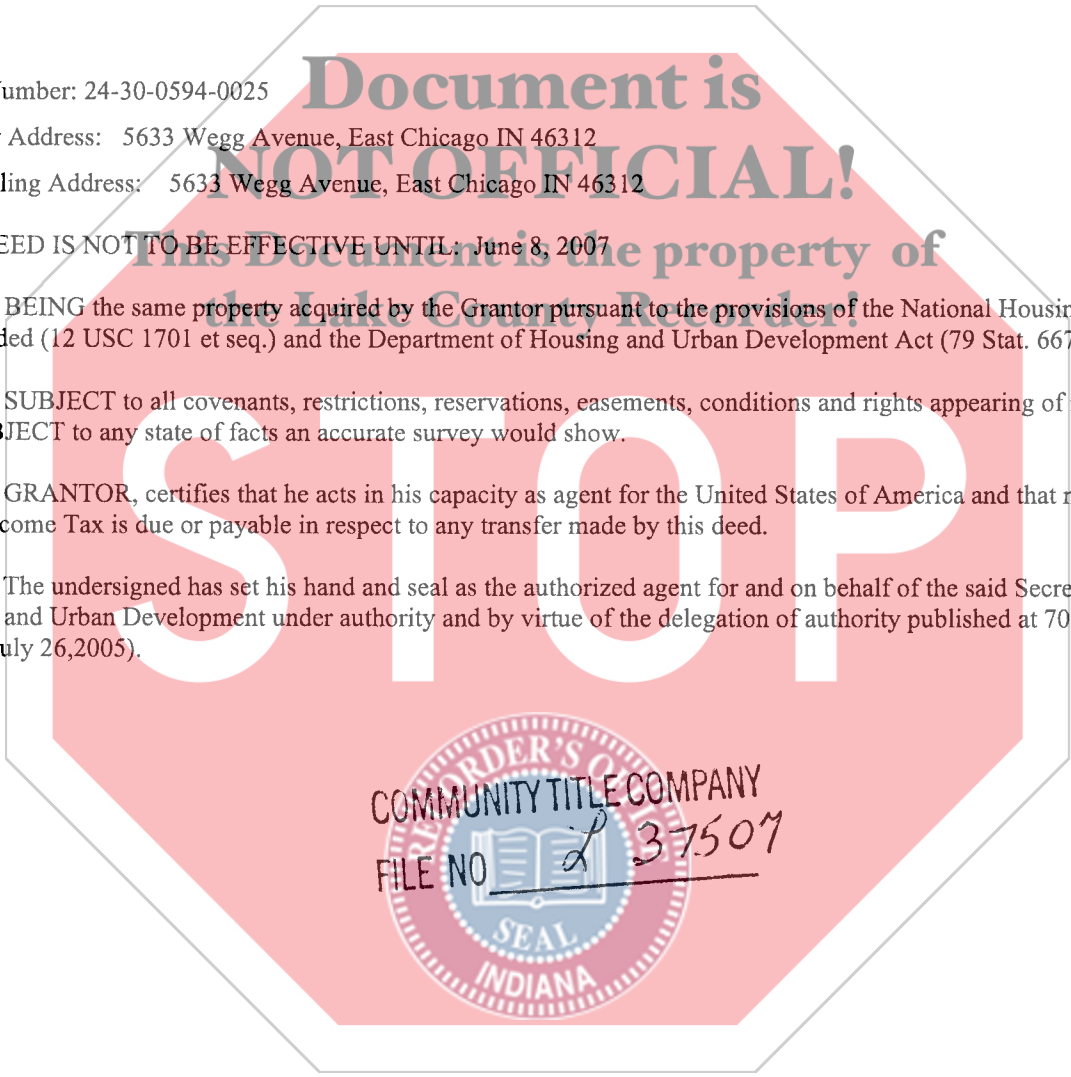
THIS DEED IS NOT TO BE EFFECTIVE UNTIL: June 8, 2007
