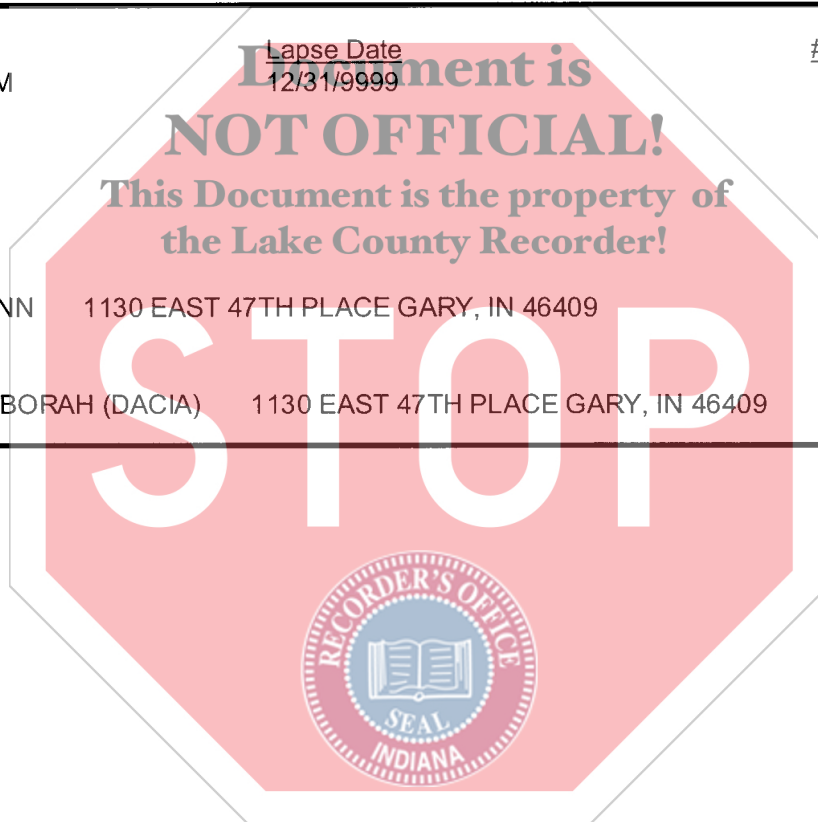

SECURITY AGREEMENT

This property now owned and hereafter acquired includes, but is not limited to proceeds, products, accounts and fixtures from crops, mine head, well head, with transmitting utilities etc., rent, wages, all income, land and mineral, water and air rights, cottages, house(s), buildings, bank accounts, bank deposit box(es), and the contents therein, savings accounts, retirement plans, stocks, bonds, securities, benefits from trusts, inheritances gotten or to be gotten, inventory in any source, all machinery either farm or industrial, livestock, livestock equipment, vehicles, auto(s), trucks, 4-wheelers, all boats and watercraft, aircraft, motor homes, fifth-wheel trailers or mobile homes, jewelry, wedding bands and/or rings, watch(es), household goods, appliance, any type furniture, kitchen utensils, cooking utensils, radio(s), television(s), musical instruments, antiques, sports equipment, rifles, guns, and any type property held for the benefit of the secured party by either the secured party or others, until the dishonor agreement, Bill of Exchange #E70141636 (attached) held by the secured party is satisfied in full and acknowledgement of the same is completed. Any property not specifically listed, named or listed by make, serial number etc., is included as the same.

The Debtor agrees to notify all employers and creditors of the same, as all debtor's wages are property of the secured party and are noticed accordingly.

This private held Security Agreement is not dischargeable in bankruptcy court, as the holder's property is **exempt (non obligated) from levy**.

Transmitting Utility

Enclosed is the proof and reasoning as to how this filing is a transmitting utility.

UCC § 9-105 (1) (n) "'Transmitting utility' means any person primarily engaged in ... the transmission of goods¹ by pipeline² ..."

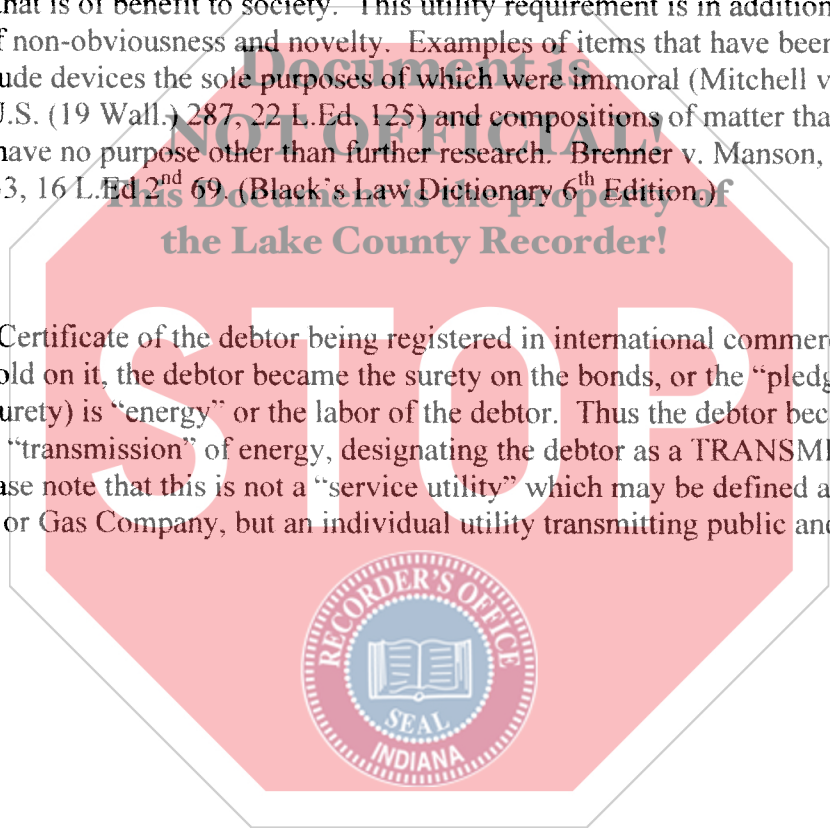
1 §9-105 (1)(n) "'Goods' also includes. . . the unborn young of animals (humans), and growing crops."

2 "Pipeline n. 1. A direct channel by which information is privately transmitted . . ." (American Heritage Dictionary – 1933)

Transmit. To send or transfer from one person or place to another, or to communicate. State v. Robbins, 253 N.C. 47, 116 S.E.2d 192, 193. (Black's Law Dictionary 6th Edition.)

Utility. In patent law, a patent applicant must demonstrate that his invention performs some function that is of benefit to society. This utility requirement is in addition to the requirements of non-obviousness and novelty. Examples of items that have been held to lack utility include devices the sole purposes of which were immoral (Mitchell v. Tilghman, 86 U.S. (19 Wall.) 287, 22 L.Ed. 125) and compositions of matter that, although new, have no purpose other than further research. Brenner v. Manson, 383 U.S. 519, 86 S.Ct 033, 16 L.Ed 2nd 69. (Black's Law Dictionary 6th Edition.)

With the Birth Certificate of the debtor being registered in international commerce and having bonds sold on it, the debtor became the surety on the bonds, or the "pledge". The asset bonded (surety) is "energy" or the labor of the debtor. Thus the debtor became the "utility" for the "transmission" of energy, designating the debtor as a TRANSMITTING UTILITY. Please note that this is not a "service utility" which may be defined as an Electric, Water or Gas Company, but an individual utility transmitting public and private debt.

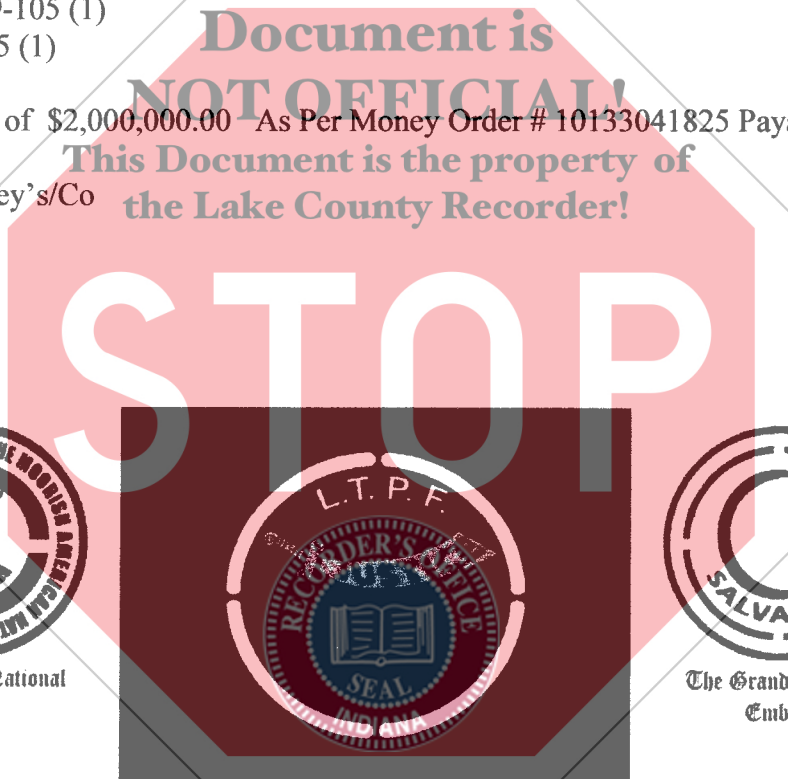
