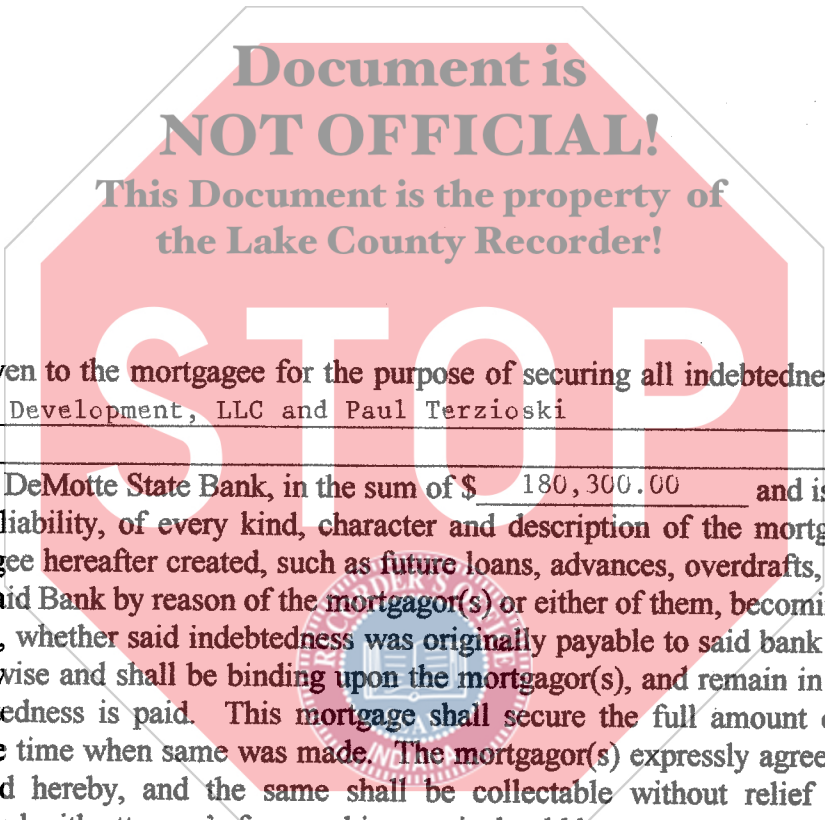

INDEMNIFYING MORTGAGE
