- 2. That she was the wife of Emil Krejci, also known as Emil E. Krejci, who died a resident of Lake County, Indiana on April 17, 1993.

3. That the decedent did have a Last Will and Testament, but that said Last Will and Testament was never probated and the time for probating the will has expired.

4. At the time of the decedent's death, he was the owner of the following described real estate located in Lake County, Indiana:

Part of the Northwest ¼ of the Southwest ¼ of Section 25, Township 36 North, Range 9 West of the 2<sup>nd</sup> Principal Meridian, in Lake County, Indiana, described as: commencing 161.43 feet North of the Southeast corner thereof; running thence West parallel with the South line thereof 490.97 feet; thence North 177.46 feet to a point 490.89 feet West of the East line thereof; thence East parallel with the South line thereof 490.89 feet to the East line; thence South along the East line 177.46 feet to the place of beginning, except the South 60 feet of the East 200 feet thereof,

More commonly known as 4260 Calhoun Street, Gary, Indiana.

5. That the decedent was married only once and that marriage was to Gloria Krejci. There were 14 children born to the marriage of the decedent and Gloria Krejci. There were no other children born to the decedent.

6. The 14 children born to the decedent and Gloria Krejci are as follows:

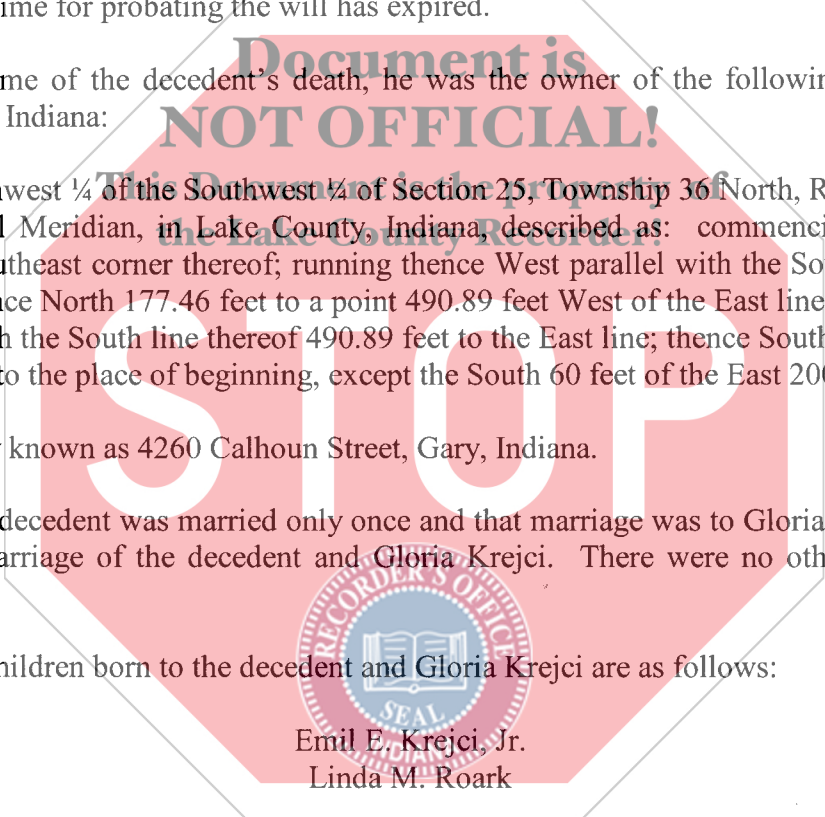
