**ORDER APPROVING FINAL REPORT AND ACCOUNT,
PETITION TO ALLOW ACCOUNT,
PETITION TO DETERMINE HEIRSHIP AND
PETITION FOR ORDER APPROVING DISTRIBUTION AND CLOSING ESTATE**

This case came to be heard on June 26, 2007, upon the Petition for Allowance of Fees and Final Account, Petition to Settle and Allow Account, Petition to Determine Heirship and Petition for Authority to Distribute Assets Remaining and Close Estate filed by Cecilia E. Ross, as personal representative of the estate of Elizabeth C. Ross, deceased.

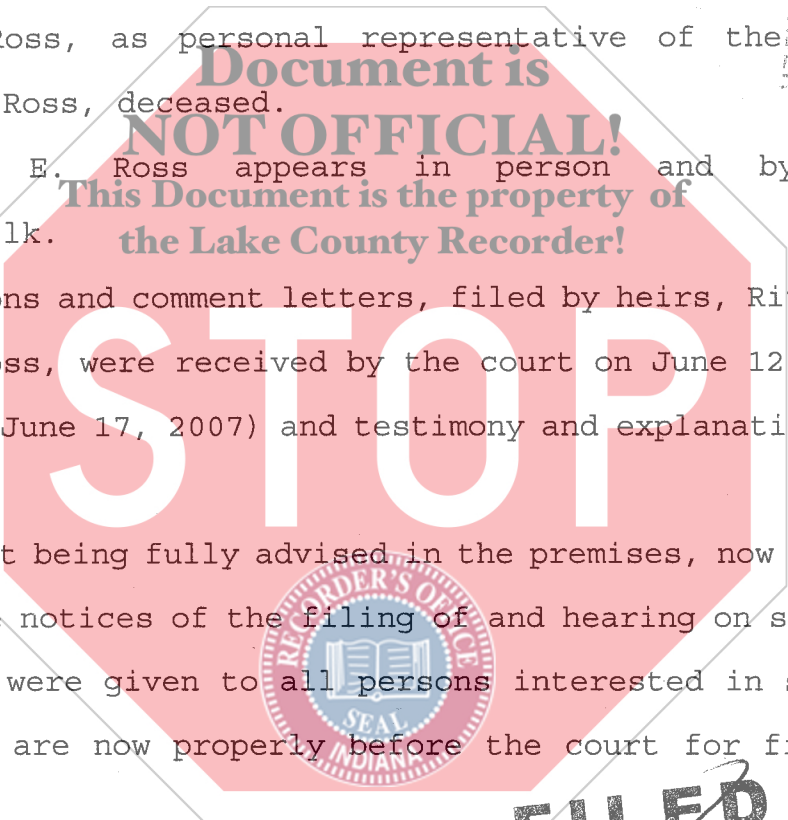
Cecilia E. Ross appears in person and by counsel, Kenneth M. Wilk.

Objections and comment letters, filed by heirs, Rita Connolly and Ursula Ross, were received by the court on June 12, 2007 (and file-stamped June 17, 2007) and testimony and explanation received thereon.

The court being fully advised in the premises, now finds that:

1. Due notices of the filing of and hearing on said account and petition were given to all persons interested in said estate and the same are now properly before the court for final action thereon.

2. That decedent, died in 2006, a resident of the County of Lake, State of Indiana on January 23, 2006, and said personal

representative was issued Letters on August 24, 2006 and since that date has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true and that said personal representative has accounted for all of the assets in this estate.

4. More than three months have elapsed since the date of the first published notice to the heirs and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither decedent nor the personal representative was an employer of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

that upon the death of said decedent, said real estate was devised to Cecilia E. Ross under Article II of decedent's Last Will and

Testament, and title to said described real estate now vests in said Cecilia E. Ross, pursuant to the terms of the will, and a copy of this decree showing the vesting of said real estate should be recorded in the office of the Lake County Recorder.

IT IS ORDERED, ADJUDGED AND DECREED by the court as follows:

1. Said final report and account is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining for distribution should be made pursuant to the distribution set forth in the final account to the decedent's heirs at law, and is hereby in all things approved.

3. Said personal representative is hereby authorized and directed to pay Kenneth M. Wilk the sum of \$ 7,000. as and for his attorney fees in the administration of the within estate.

4. Estate expenses in the amount of \$13,130.03, which were paid out-of-pocket by Cecilia E. Ross, as personal representative of the estate of Elizabeth C. Ross, deceased, shall be paid by the estate to Cecilia E. Ross.

5. Cecilia E. Ross is hereby devised under Article II of decedent's Last Will and Testament, the real estate located at 4110 Towle in Hammond, Lake County, Indiana

6. Said personal representative is directed to distribute and pay over the balance of the estate for distribution, as follows:

▶ THE APPROXIMATE SUM OF \$5,414.38, AS SET FORTH IN THE ABOVE DISTRIBUTION REPRESENTS ONE-FIFTH OF THE BALANCE REMAINING FROM THE VALUE OF THE LIQUIDATED STOCK LESS REIMBURSEMENT OF OUT-OF-POCKET COSTS PAID BY CECILIA ROSS

▶ DISTRIBUTION TO ALL HEIRS IS SUBJECT TO PAYMENT OF COURT ORDERED ATTORNEYS FEES, ACCOUNTANT FEES, FINAL INCOME TAXES AND COSTS

7. Following the payment of attorneys fees and the distribution to the named heirs, any residual money in the estate is to be distributed equally amongst the named heirs set out above.

8. Said personal representative is hereby directed to file a supplemental report showing that all terms of this order have been complied with and that said personal representative has in all things carried out the provisions of this final decree and is hereby released and discharged from any further liability or responsibility along with said surety as said personal representative of the estate.

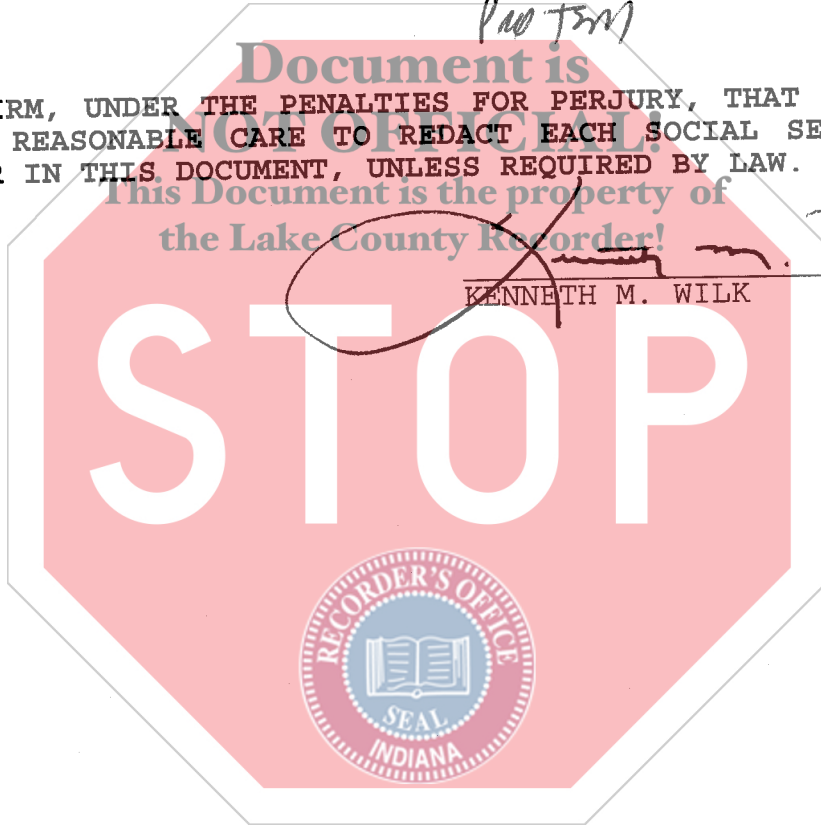

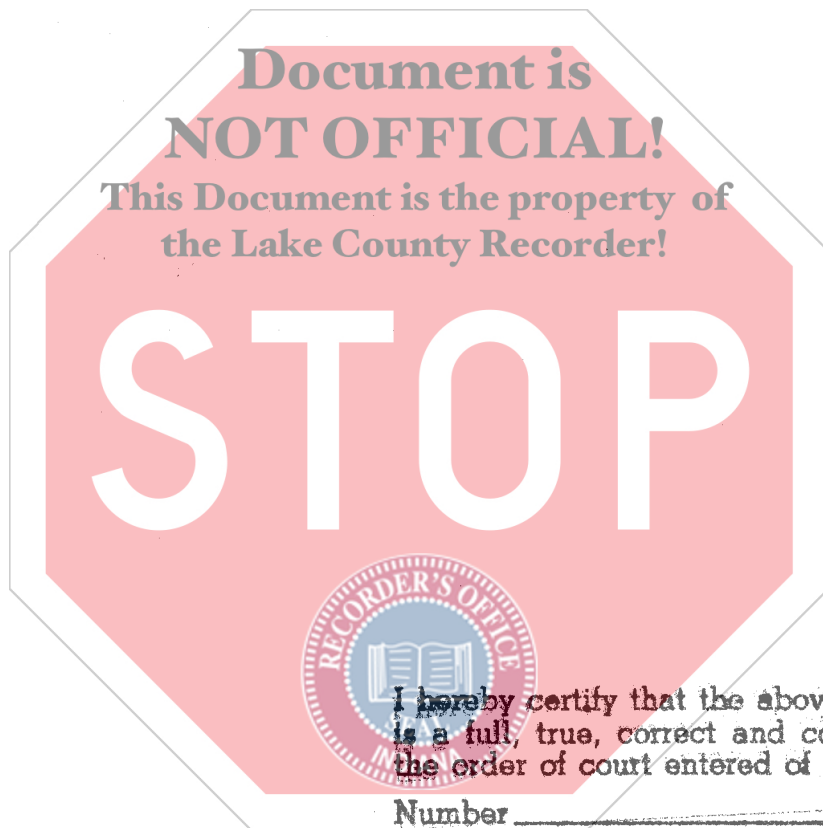
