- B. The transfer of the parcels to the City of Gary is to be effectuated by Quit Claim Deed.
- C. The transfer shall be made for a price of One Dollar and (\$1.00) and other goods and valuable considerations.
- D. This Resolution shall be effective upon its adoption by the Board of Redevelopment Commissioners of the City of Gary, Indiana

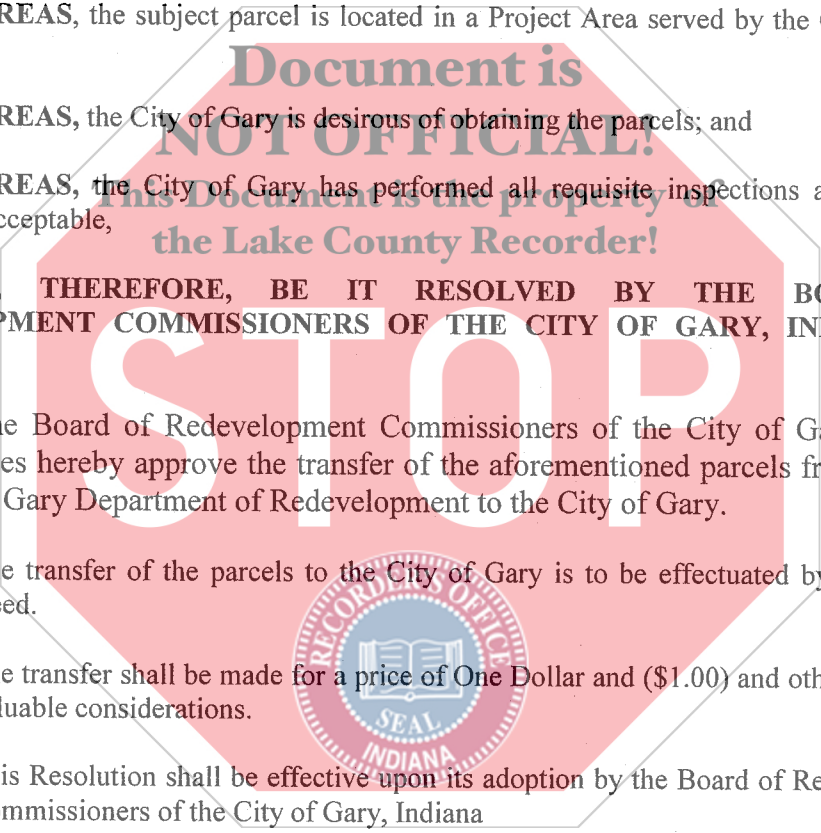
