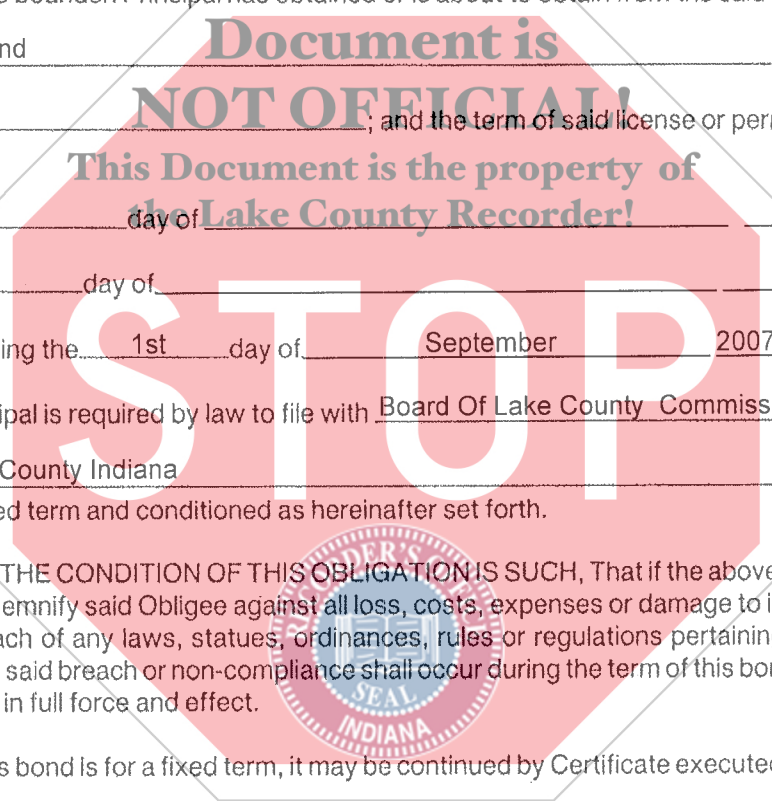

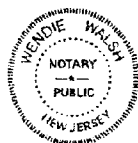

CERTIFICATION
