KNOW ALL MEN BY THESE PRESENTS:

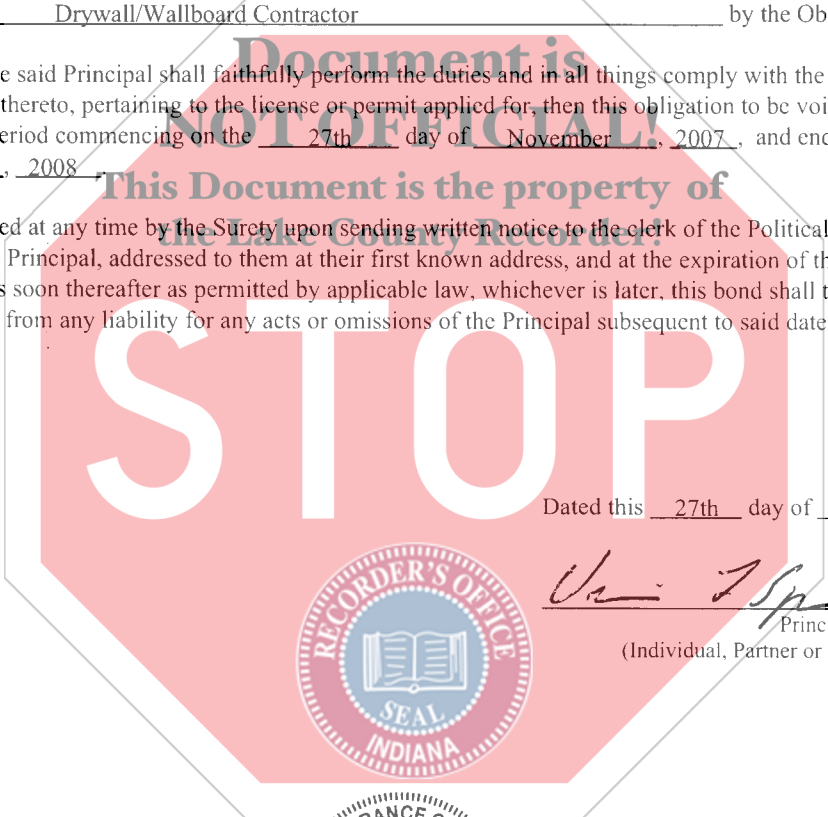
That we, All Chicagoland Construction LLC
