**COURT ORDER**

This matter comes before the Court on this 29<sup>th</sup> day of November, 2004 for a determination of the fine to be imposed in this matter. The City of Whiting is represented by its City Prosecutor for Ordinance Violations, Joseph M. Skozen, and the Defendant, Damian Santay, appears pro se.

The Defendant was charged in this matter by the City of Whiting for being in violation of City Ordinances with the following two properties:

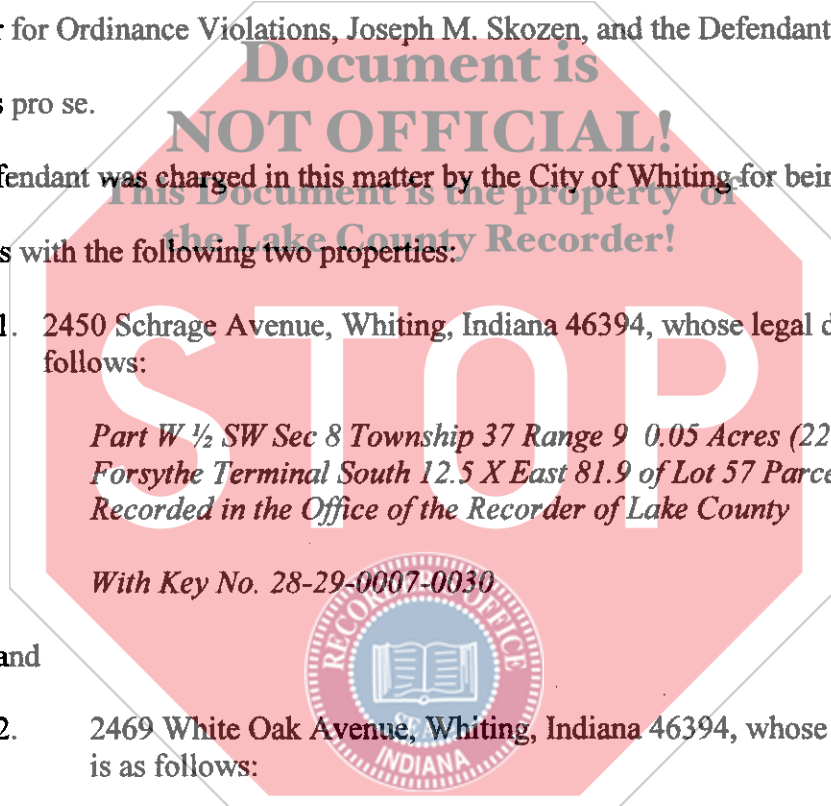

This matter is submitted for trial on the 26<sup>th</sup> day of July, 2004 on the pending City Ordinance Violation charges. The Court, being duly advised in the premises, and having examined the pleadings, heard testimony and received evidence, found the Defendant to be in violation of the Whiting City Ordinances at each of his two properties at 2450 Schrage Avenue, Whiting, Indiana 46394 and 2469 White Oak Avenue, Whiting, Indiana 46394.

**IT IS THEREFORE ORDERED, ADJUDGED and DECREED** that the Defendant, having been found to have violated the City Ordinances as charged at each of his two properties at 2450 Schrage Avenue, Whiting, Indiana 46394 and 2469 White Oak Avenue, Whiting, Indiana 46394, is hereby fined the amount of Five Hundred Dollars per day from 05/01/04 through 7/26/04 (87 days). All of the said fine except for the amount of Ten Thousand Dollars (\$10,000.00) and Court Costs is hereby suspended. The Defendant is ordered to pay the fine of Ten Thousand Dollars (\$10,000.00) plus court Costs to the Clerk of the Whiting City Court.

**IT IS FURTHER ORDERED** that this Order shall be recorded with the Lake County Auditor's Office and the Lake County Recorder's Office as a lien in the amount of Ten Thousand Dollars (\$10,000.00) along with Court Costs and accrued interest against the two properties at 2450 Schrage Avenue, Whiting, Indiana 46394 and 2469 White Oak Avenue, Whiting, Indiana 46394 until said Ten Thousand Dollars (\$10,000.00) Fine, along with the Court Cost and accrued interest are satisfied.
