POWER OF ATTORNEY

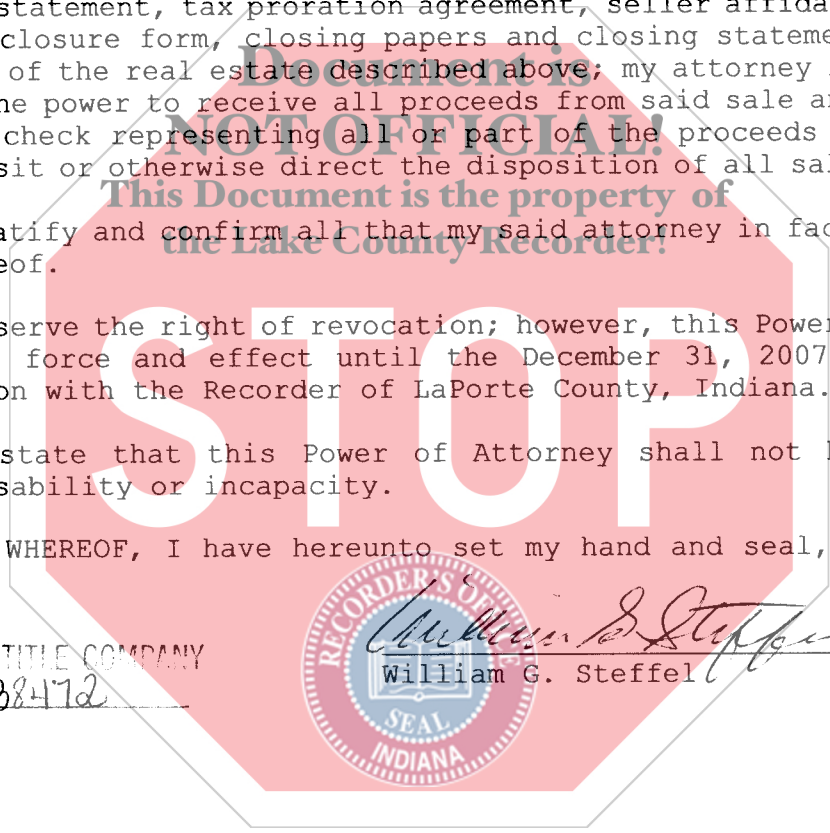

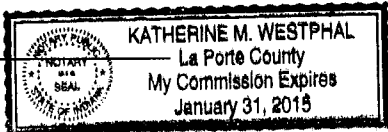

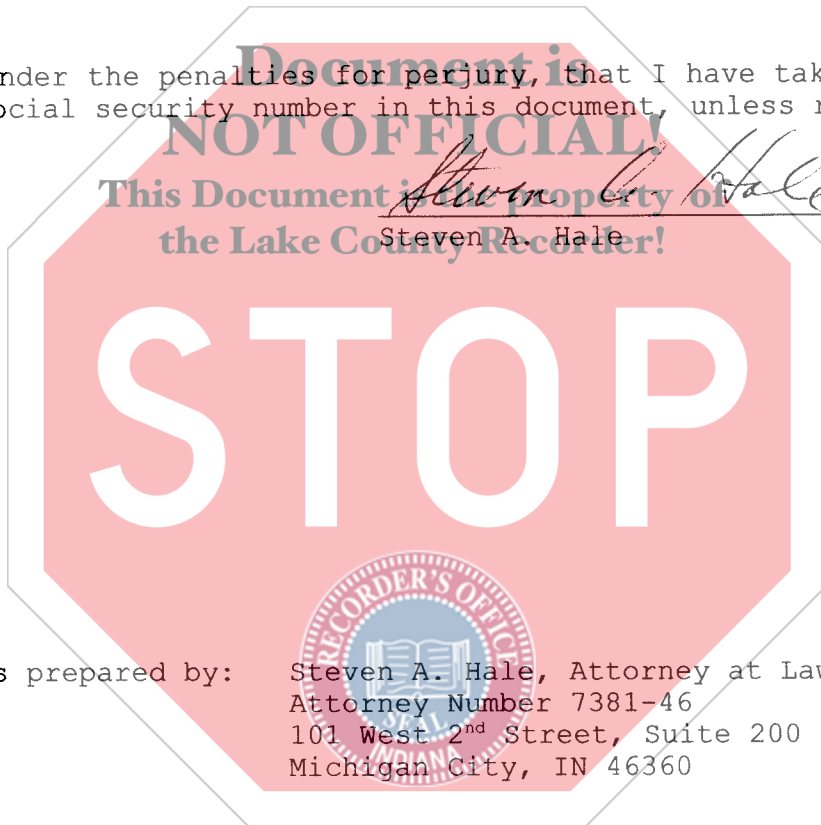
