

3. The work and labor were done, and the materials furnished by the undersigned within the last sixty (60) days. Ready Mix Concrete



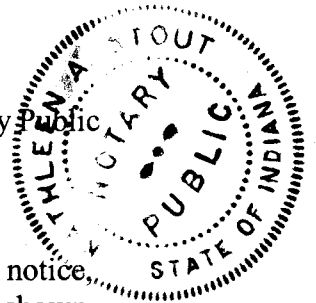


