**THIRD**

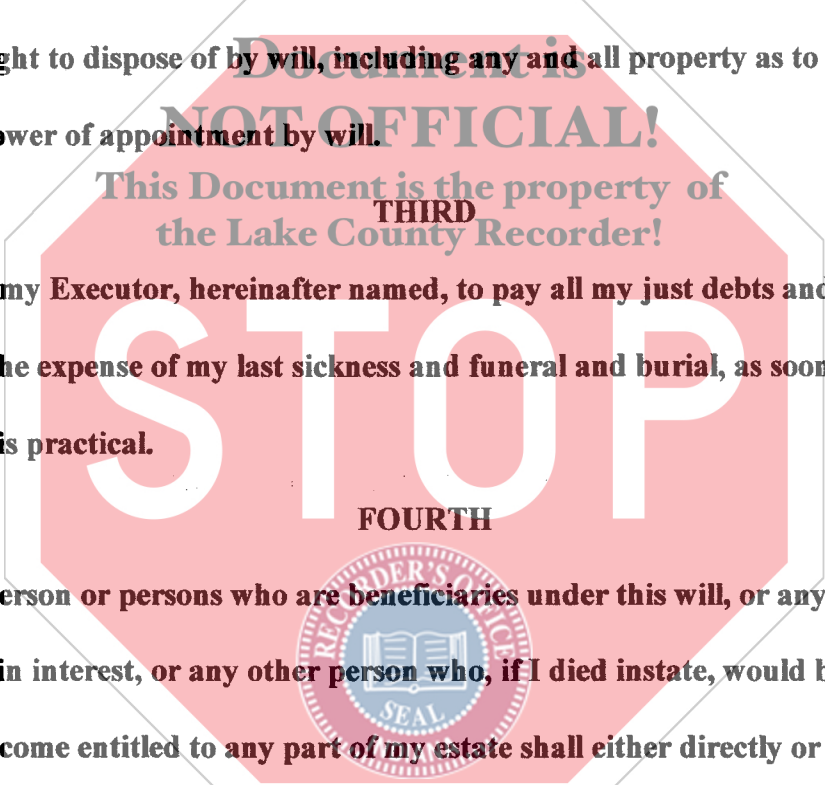
I direct my Executor, hereinafter named, to pay all my just debts and obligations, including the expense of my last sickness and funeral and burial, as soon after my decease as is practical.

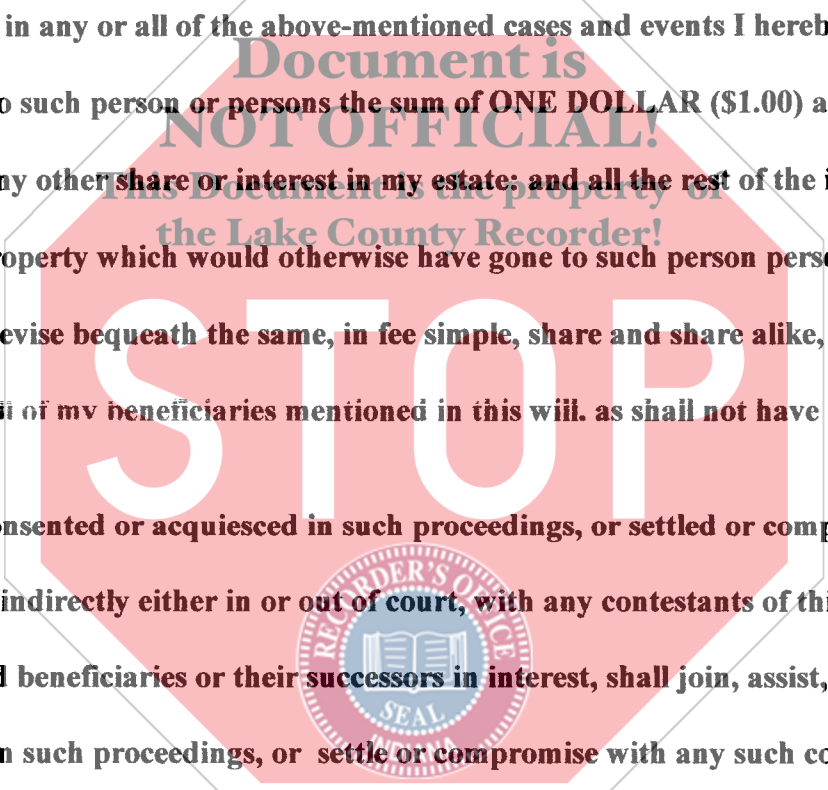

provisions, or to have the same or any part thereof or any legacy or legacies or devise or devises or trust herein limited, declare void, or diminished, or to defeat or change any part of the testamentary plan of this will, or commence any suit in any court whatsoever or by any ways or means sue and disturb or cause to be sued and disturbed, my executor herein names, or to settle or compromise, directly or indirectly, either in or out of court with any persons who shall attempt to do any of the above, or shall consent to, acquiesce in or fail to contest any such proceeding, or shall endeavor to secure or take any part of my estate in any manner other than through or under this will, or be a party to any pleading or proceeding as above set forth, then in any or all of the above-mentioned cases and events I hereby give and bequeath to such person or persons the sum of ONE DOLLAR (\$1.00) and no more in lieu of any other share or interest in my estate; and all the rest of the interest, share or property which would otherwise have gone to such person persons by legacy or devise bequeath the same, in fee simple, share and share alike, to such, ~~been and all of my beneficiaries mentioned in this will. as shall not have made.~~ joined, assisted, consented or acquiesced in such proceedings, or settled or compromised, directly or indirectly either in or out of court, with any contestants of this will: and if all of said beneficiaries or their successors in interest, shall join, assist, consent or acquiesce in such proceedings, or settle or compromise with any such contestants, I hereby give, devise and bequeath in fee, the whole of my estate to my next heirs at law, excluding said beneficiaries, their successors in interest, and such contestants, according to the laws of succession then in force in the State of Indiana, anything to



the contrary in this notwithstanding.

FIFTH

I hereby give, devise and bequeath the rest and residue of my estate to Rebecca Tucker.

SIXTH

I hereby nominate and appoint Rebecca Tucker the Executor of this my Last Will and Testament to serve without bond.

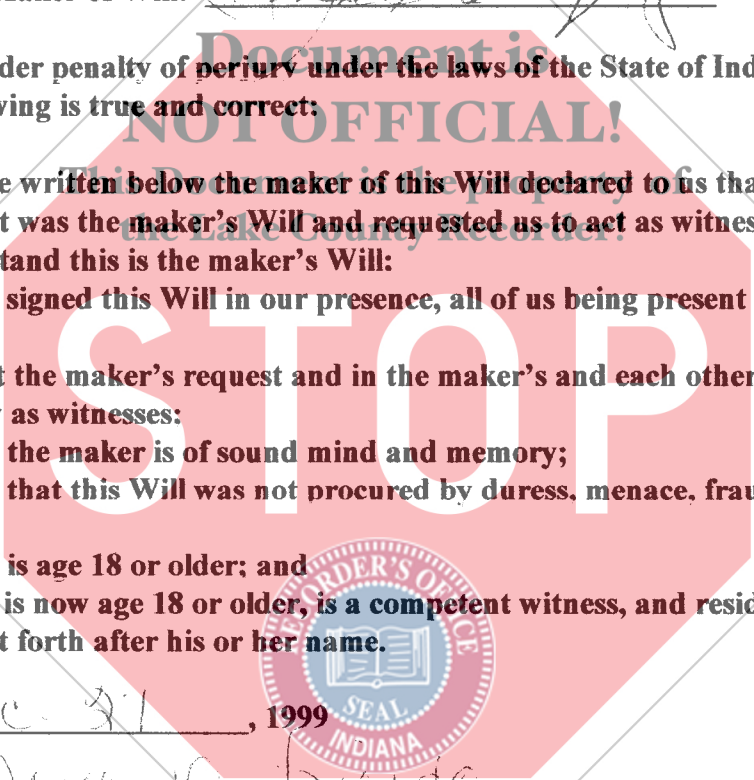
1. on the date written below the maker of this Will declared to us that this instrument was the maker's Will and requested us to act as witnesses to it;



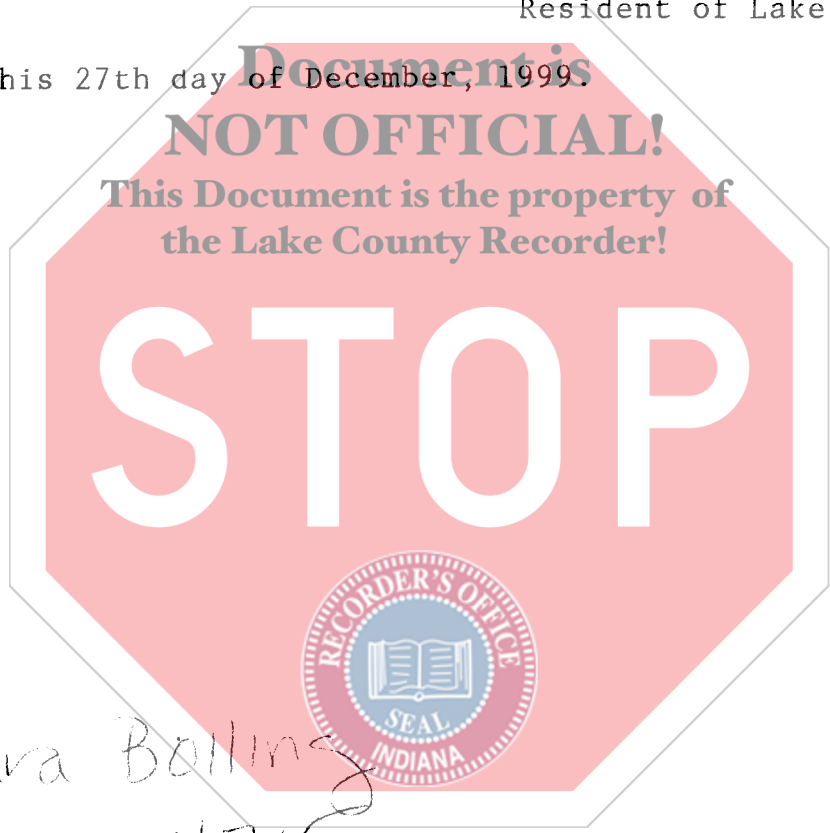
