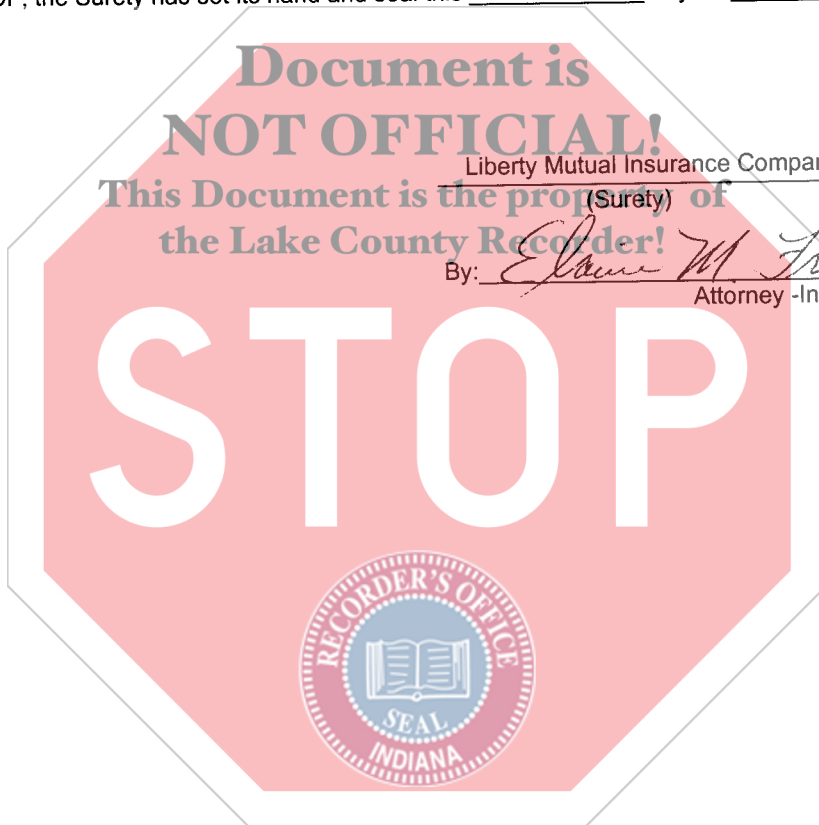

POWER OF ATTORNEY

KNOW ALL PERSONS BY THESE PRESENTS:

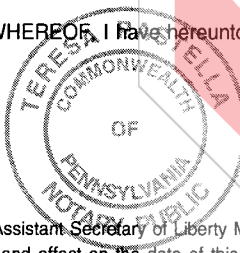
