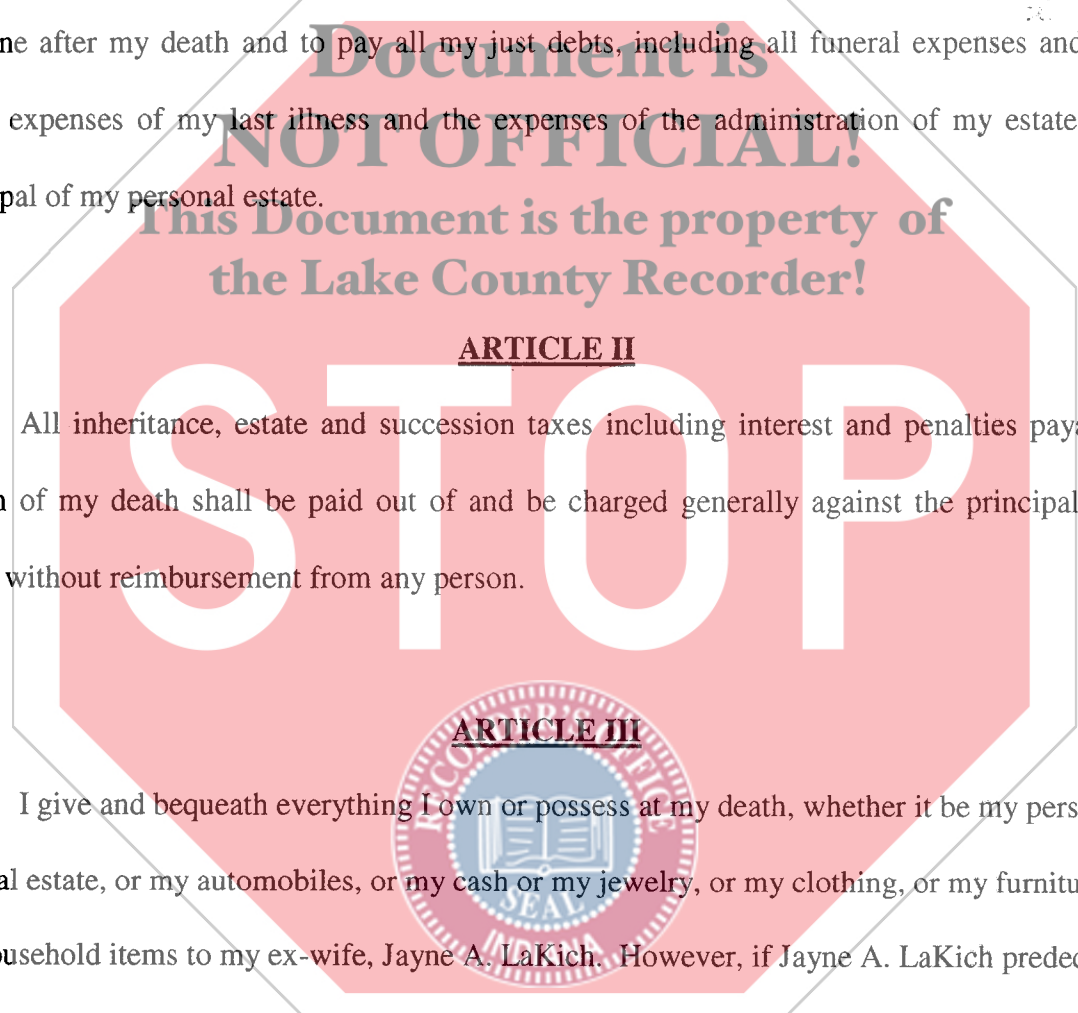

ARTICLE I

ARTICLE III

I give and bequeath everything I own or possess at my death, whether it be my personal or my real estate, or my automobiles, or my cash or my jewelry, or my clothing, or my furniture, or my household items to my ex-wife, Jayne A. LaKich. However, if Jayne A. LaKich predeceases me, then everything will go to my three loving and adoring children, Erik N. LaKich, Mindy J. LaKich and Jessica L. Lakich, to be divided equally, share and share alike. However, if one of my said children predeceases me, than his or her share shall go to his or her natural born child or children and then be divided by my then living children.

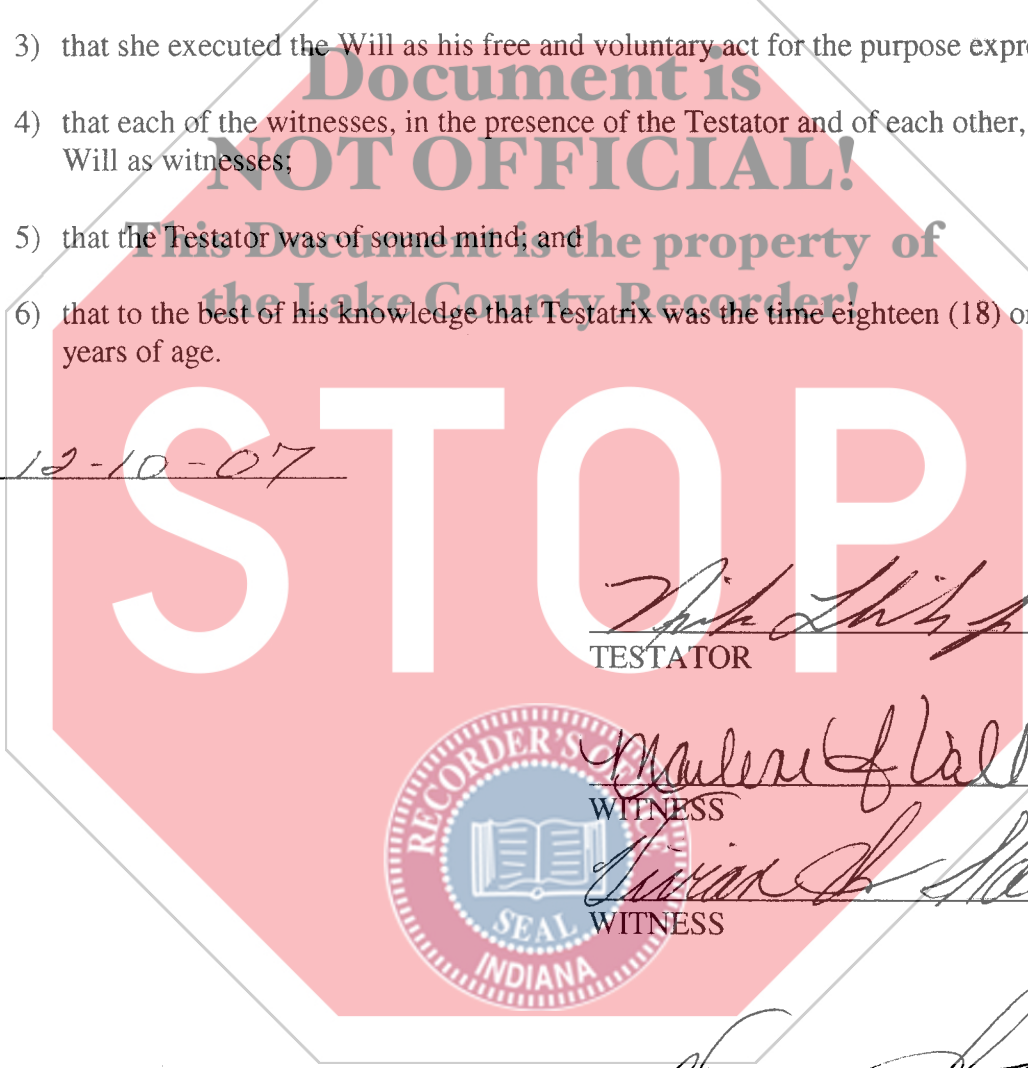
