ARTICLE III

I give and bequeath everything I own or possess at my death, whether it be my personal or my real estate, or my automobiles, or my cash or my jewelry, or my clothing, or my furniture, or my household items to my ex-husband Nick LaKich, Jr. However, if Nick LaKich, Jr., predeceases me, then everything will go to my three loving and adoring children, Erik N. LaKich, Mindy J. LaKich and Jessica L. Lakich, to be divided equally, said and share alike. However, if one of my said children predeceases me, than his or her share shall go to his or her natural born child or children and then be divided by my then living children.

ARTICLE IV

I hereby designate and appoint my ex-husband, Nick LaKich, Jr., as executor and my son, Eric N. LaKich to be co-executor of this my Last Will and Testament and if either one predeceases the other, than the survivor shall be the sole executor of my estate. No bond is required of any executor.

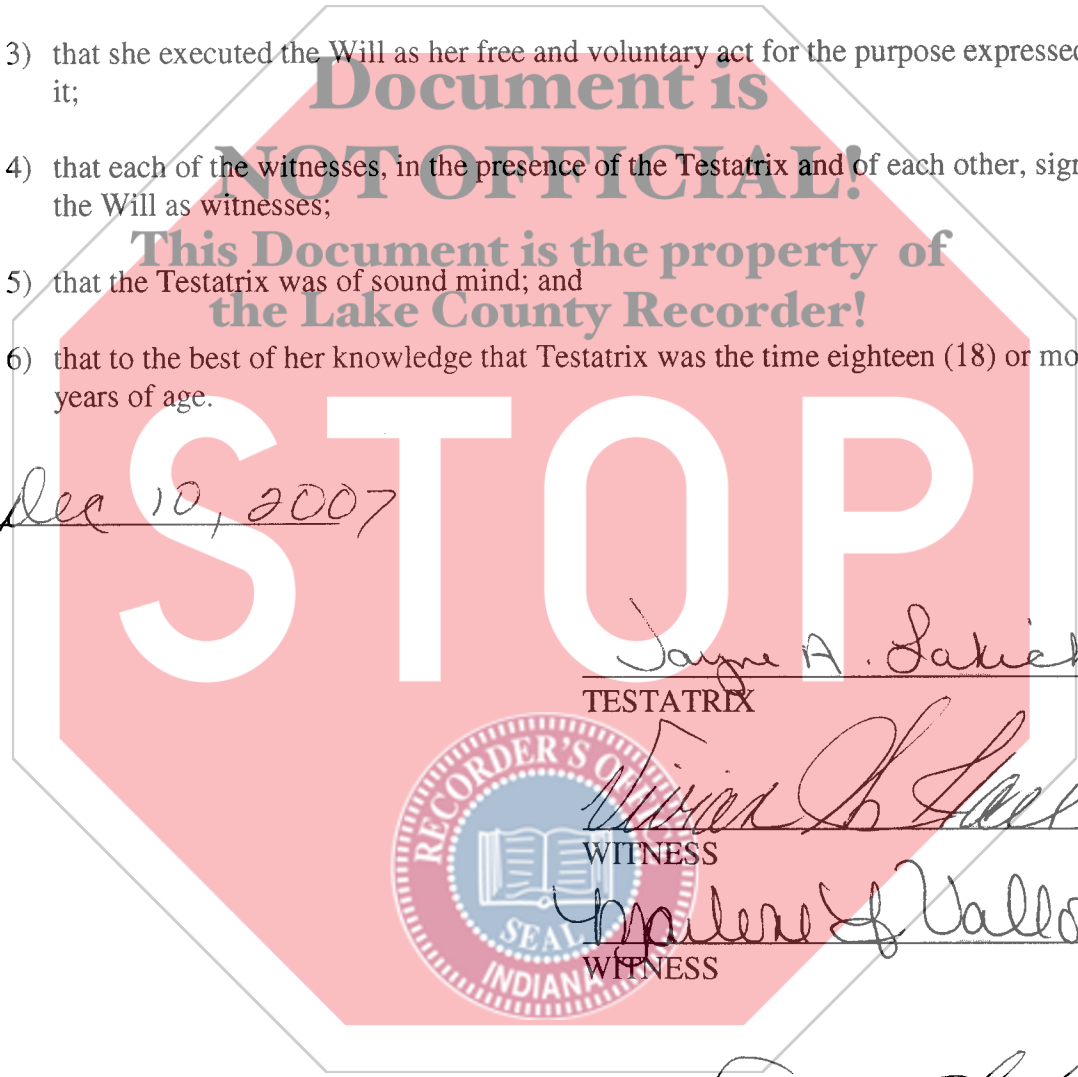
