SWORN STATEMENT OF INTENTION TO HOLD LIEN

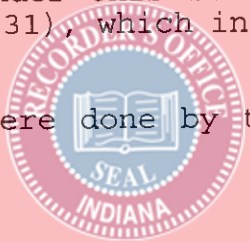


