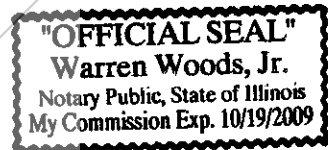

**LEGAL DESCRIPTION**  
**SCHEDULE "A"**

A parcel of real estate in the Southeast Quarter of the Northeast Quarter of Section 36, Township 35 North, Range 6 West of the Second Principal Meridian, in Porter County, Indiana, described as follows: Commencing at the Southeast corner of said Southeast Quarter Quarter; thence South 90 degrees 00 minutes 00 seconds West, along the South line of said Southeast Quarter Quarter, 464.40 feet to the POINT OF BEGINNING; thence continuing South 90 degrees 00 minutes 00 seconds West, along said South line, 257.44 feet to a point in the centerline of Sager Road; thence along said centerline the following 2 courses and distances: North 35 degrees 10 minutes 56 seconds West 69.88 feet, North 17 degrees 13 minutes 23 seconds West 147.20 feet; thence North 74 degrees 24 minutes 29 seconds East 152.88 feet; thence North 90 degrees 00 minutes 00 seconds East 159.12 feet; thence South 14 degrees 47 minutes 14 seconds East 246.85 feet to said South line; thence South 90 degrees 00 minutes 00 seconds West, along said South line, 28.10 feet to the point of beginning.
