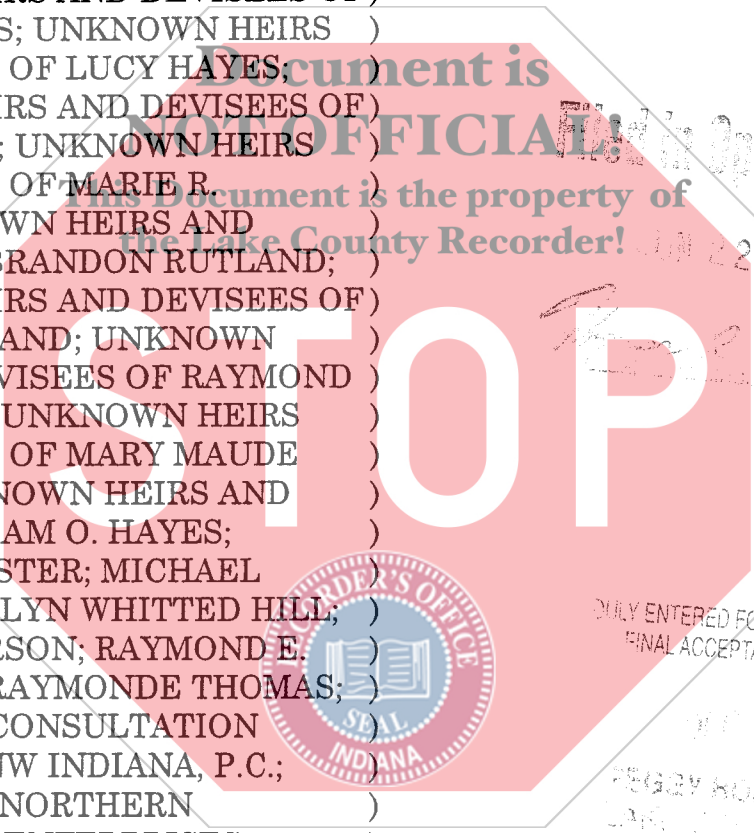

Book 6, page 23, in the Office of Recorder of Lake County, Indiana.

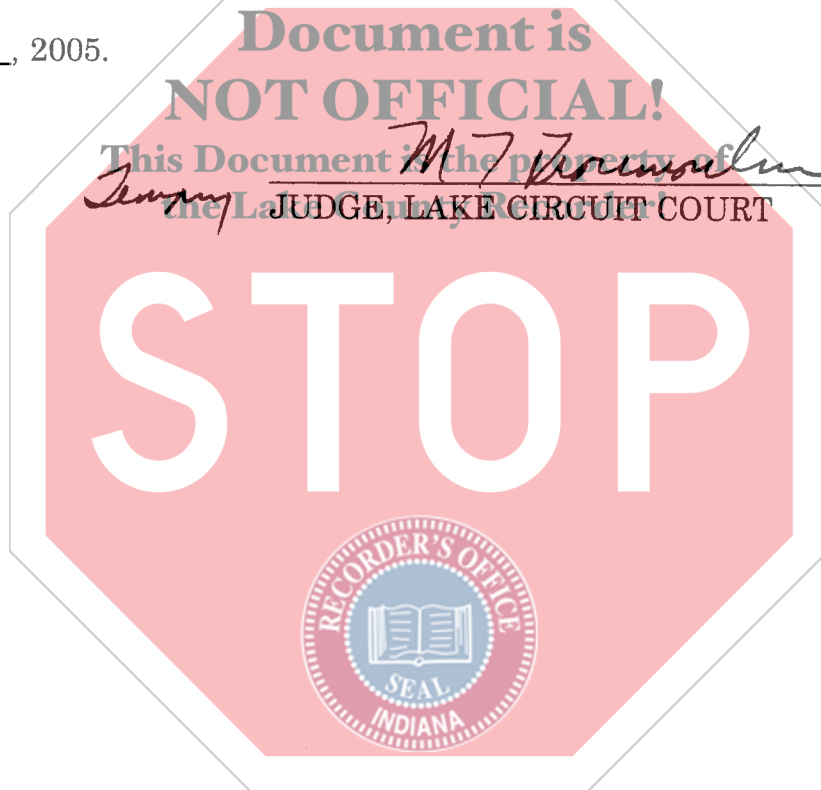
3. The claims of the defendants, their successors and assigns are without right and unfounded.

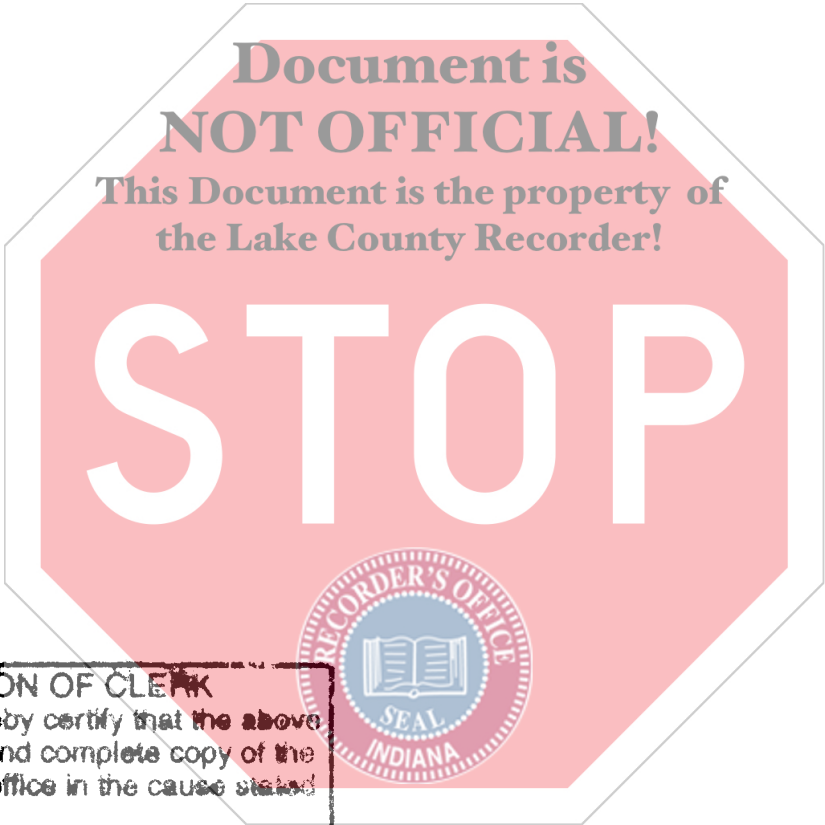
