SUCCESSOR TRUSTEES

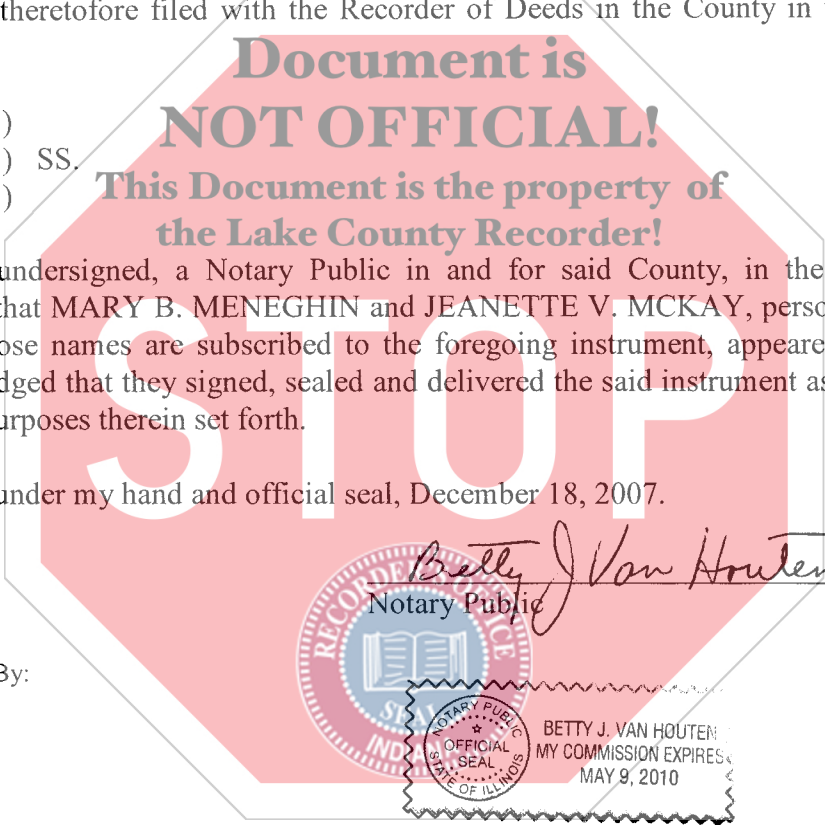
The Trust Agreement referred to herein provides that the following persons or entity shall act as Successor Trustee or Successor Trustees hereunder in the following order:
