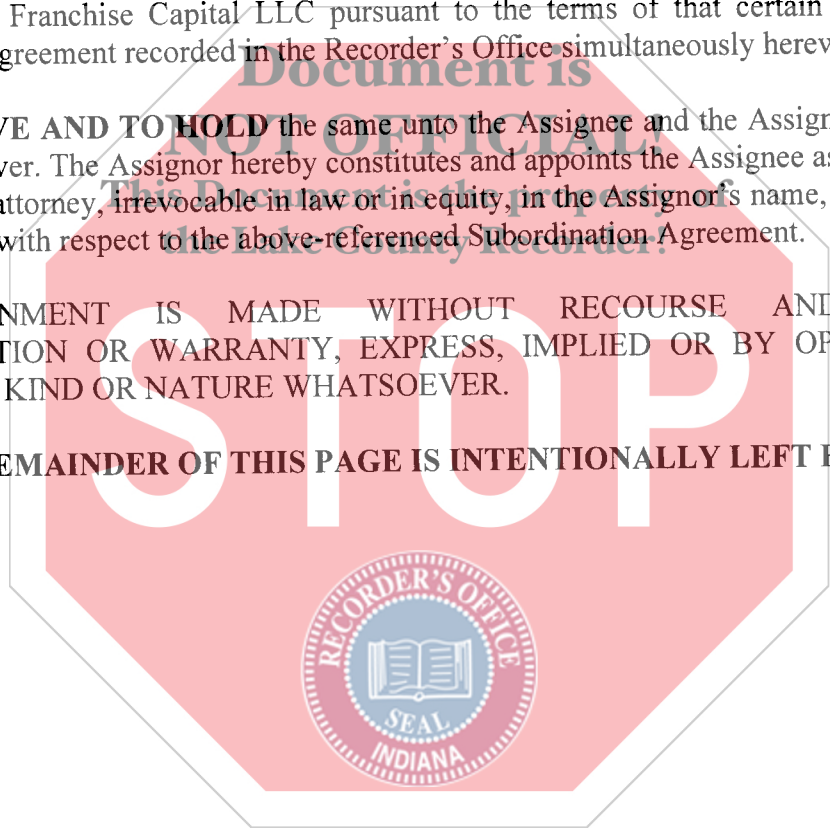
ASSIGNMENT OF SUBORDINATION AGREEMENT

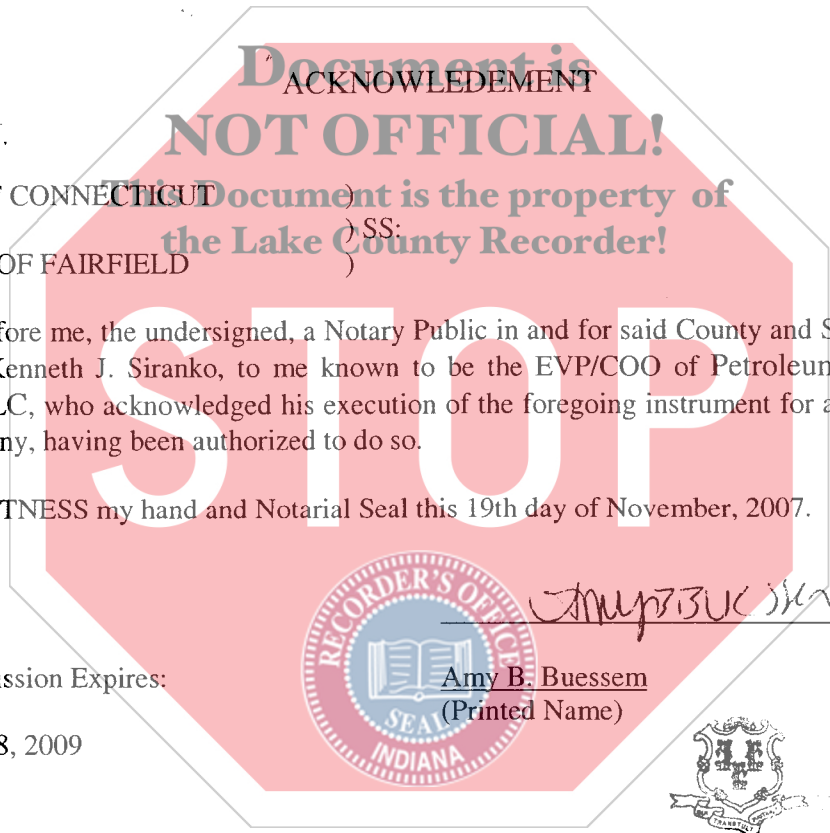




