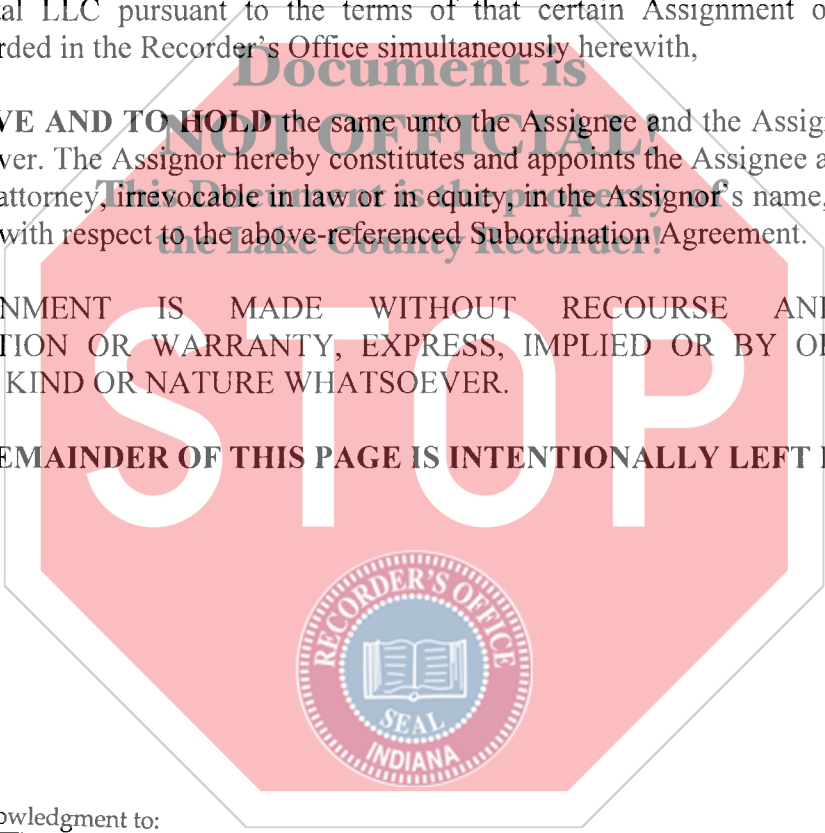
ASSIGNMENT OF SUBORDINATION AGREEMENT



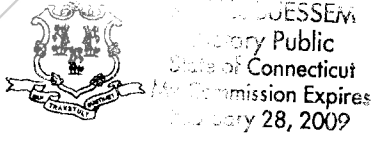
