ADDENDUM TO FIRST AMENDMENT TO LEASE BETWEEN THE MUNSTER SCHOOL BUILDING CORPORATION, LESSOR, AND THE SCHOOL TOWN OF MUNSTER, LAKE COUNTY, INDIANA, LESSEE

THIS ADDENDUM TO FIRST AMENDMENT TO LEASE (this "Addendum to First Amendment to Lease"), entered into as of this 15th day of November, 2007, by and between the Munster School Building Corporation, an Indiana nonprofit corporation (the "Lessor"), and the School Town of Munster, Lake County, Indiana, a public school corporation existing under the laws of the State of Indiana (the "Lessee");

WITNESSETH:

WHEREAS, the Lessor and Lessee previously entered into a Lease, dated as of July 25, 2003 (the "Original Lease"), as previously amended by an Addendum to Lease, dated as of November 1, 2003 (the "First Addendum"), a Second Addendum to Lease, dated as of November 1, 2004 (the "Second Addendum"), a Third Addendum to Lease, dated as of November 1, 2005 (the "Third Addendum") and a First Amendment to Lease, dated as of October 19, 2007 (the "First Amendment to Lease") (the Original Lease, as amended by the First Addendum, the Second Addendum, the Third Addendum and the First Amendment to Lease, collectively, the "Lease"); and

WHEREAS, it is provided in the Lease that there shall be endorsed thereon the adjusted rental and the date on which the payment of rentals shall commence.
