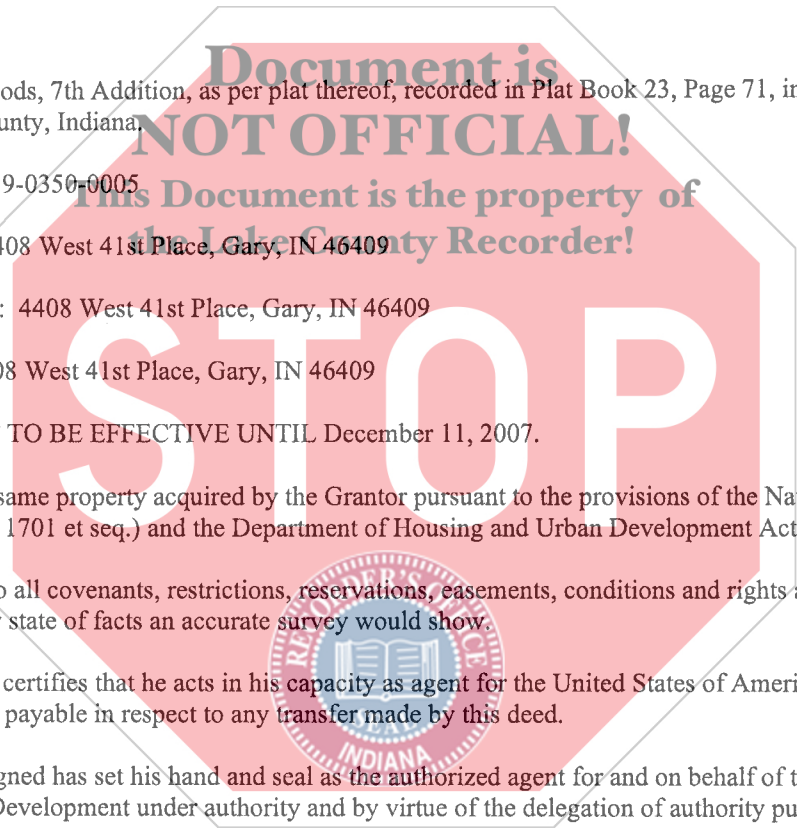
THIS DEED IS NOT TO BE EFFECTIVE UNTIL December 11, 2007.
