ORDER APPROVING PERSONAL REPRESENTATIVE'S FINAL REPORT AND ACCOUNTING, PETITION TO ALLOW ACCOUNTING, PETITION FOR ORDER APPROVING DISTRIBUTION AND CLOSING ESTATE

This cause came to be heard on this 27th day of November, 2007, upon the Final Report and Accounting, Petition to Settle and Allow Account, and for Authority to Distribute Estate filed by DANA GORE, a/k/a DANA MARIE ALEXANDER GORE, Personal Representative of the Estate of RUTH A. NETTLES, deceased, which account and petition are on file with the Court and a part of the Court's record.

And it appearing that no objections were filed thereto and the Court, being advised in the premises, now finds that:

1. Due notice of the filing of said accounting and petition and the hearing on the same were given to all persons interested in said estate. That a formal notice was published pursuant to the provisions of I.C. 29-1-16-6 and that this matter is now properly before this Court for final action thereon.

2. That RUTH A. NETTLES died testate a resident of Gary, Lake County, Indiana, on the 26th day of May, 2006, and her Last Will and Testament was duly admitted to probate before this Court on the 13th day of February, 2007, and this Court appointed said DANA GORE as Executrix of the Last Will and Testament of the decedent, and said Executrix was issued Letters Testamentary on the 13th day of February, 2007, and since that date he has continued to serve in such capacity.

3. That the matters and things stated in said accounting and petition are true, and that said Executor has accounted for all the assets in this estate coming into her hands.

4. More than five (5) months have elapsed since the date of the first published notice to legatees, devisees, and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor his Executor were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; and all estate taxes, inheritance taxes, and gross income taxes, if any, assessed in said estate have been paid.

5. That the following persons are the sole legatees/ devisees under the decedent's Last Will and Testament, to-wit: DANA MARIE ALEXANDER GORE, NIECE.

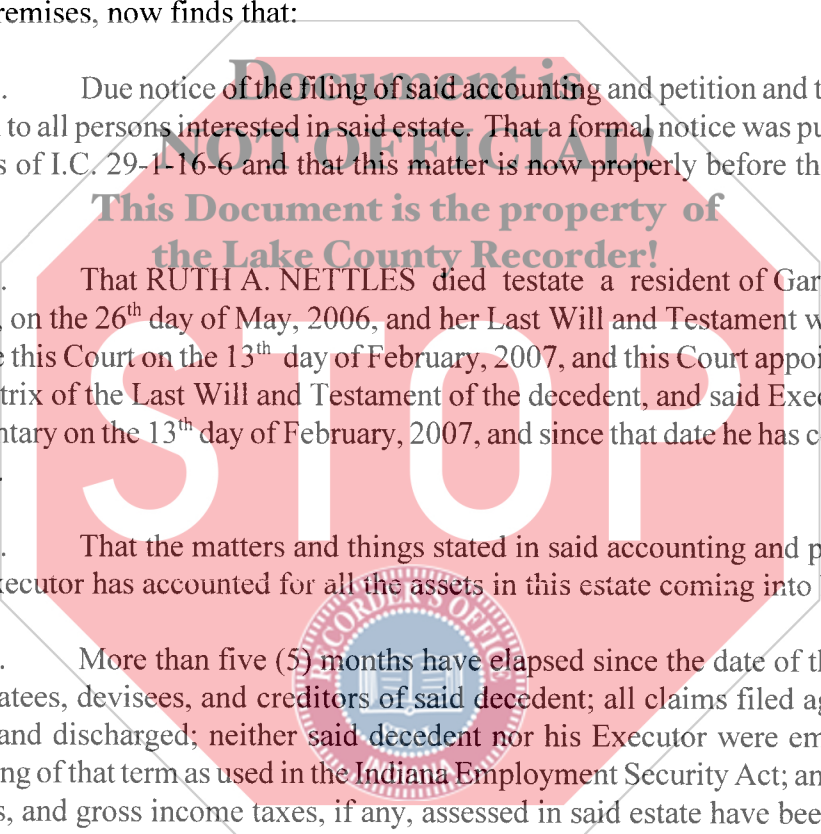
That there were no cash assets to be distributed under the administration of this estate.
