**MEMORANDUM OF RESTATEMENT OF THE
CHAPKO, JR. LIVING TRUST**

1. On November 21, 2007, we Restated our Trust, known as the Chapko, Jr. Living Trust, "Trust", which was originally executed on August 16, 1991, Restated June 16, 1997, and Restated again on November 21, 2007.
