DEED

TOGETHER with appurtenances and all the estate and rights of Grantor in and to said premises,

BUT RETAINING to Grantor the right to use, possess, occupy, and reside upon the premises during the life of Grantor, so that the beneficial interest and possessory rights so retained shall constitute in all respects "equitable title to real estate" within the meaning of the Constitution of the State of Indiana.

TO HAVE AND TO HOLD the premises herein granted unto Grantee and the heirs, personal representatives, executors, administrators, successors and assigns of Grantee forever.




