Commonly known as 1165 Waite Street, Gary, Indiana 46404 (hereafter referred to as "Real Estate").

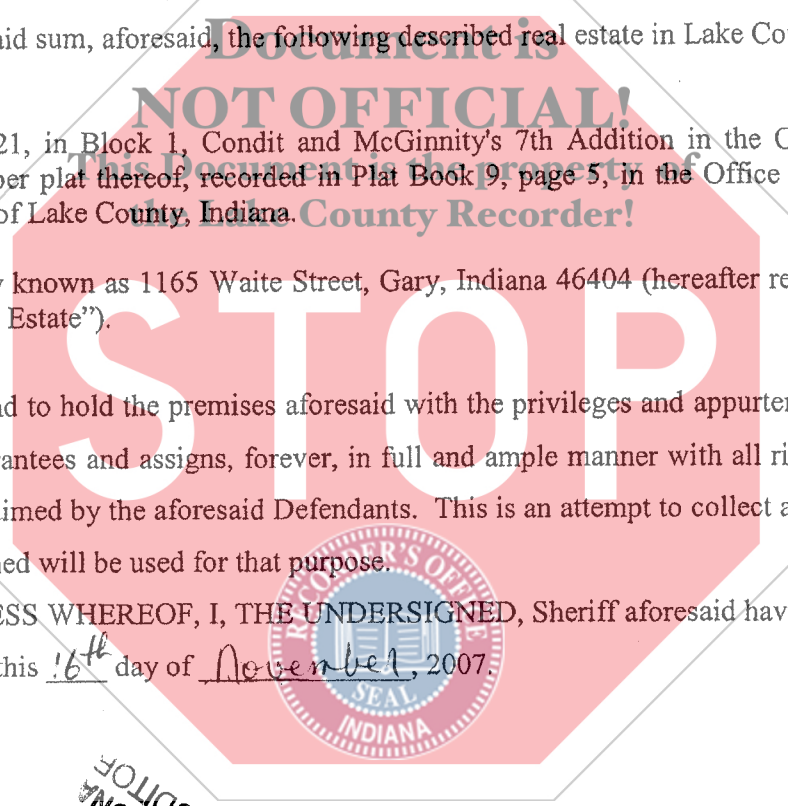
