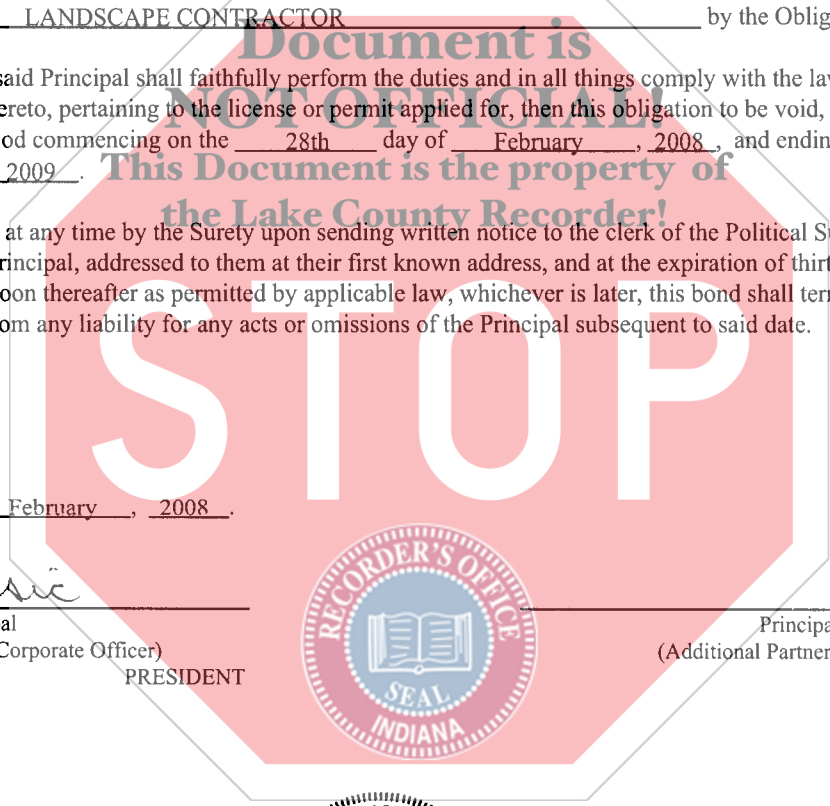

# POWER OF ATTORNEY
