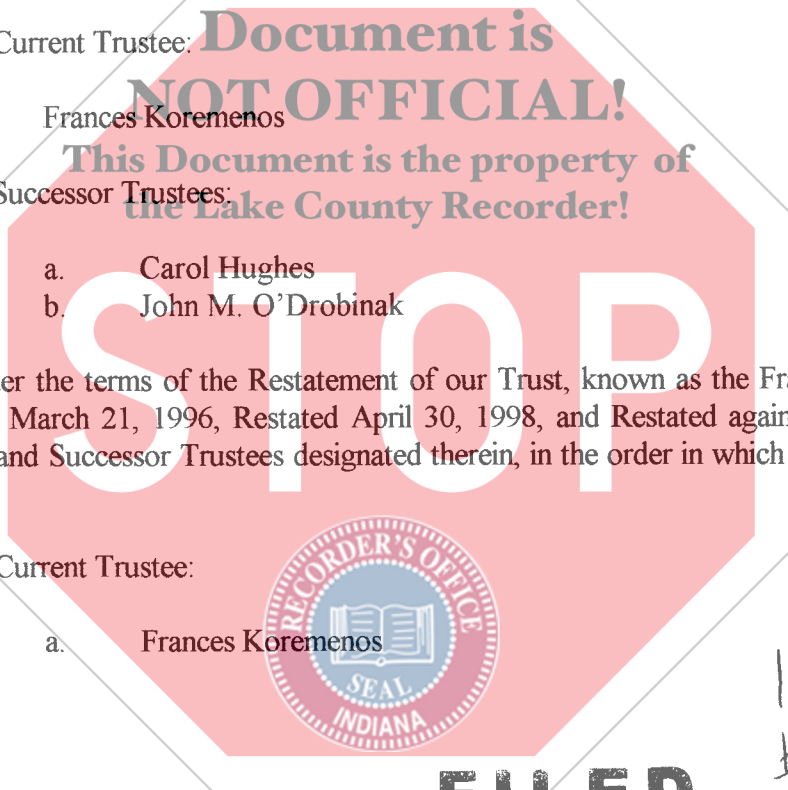

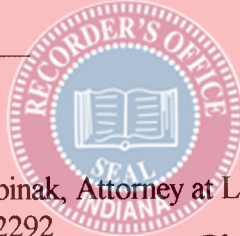

PARCEL ONE:

Part of the Northwest Quarter of the Southeast Quarter of Section 17, Township 35 North, Range 9 West of the 2nd Principal Meridian, described as: Commencing at the Northwest corner of Outlot "F", Schilling's Edgewood Addition, as shown in Plat Book 28, page 5 and running thence South 300 feet to the South line of said tract; thence West 50 feet to the East line of a tract conveyed to Joseph C. Seifert and wife Josephine by deed dated September 11, 1951, and recorded September 13, 1951, in Deed Record 896, page 560; thence North along said East line 300 feet to the South line of Southview Drive; thence East along the South line of Southview Drive to the point of beginning, in Lake County.

PARCEL TWO:

Out Lot "F", as marked and laid down on the recorded plat of Schilling's Edgewood Add., being a subdivision of the Northwest Quarter of the Southeast Quarter and the Northeast Quarter of the Southwest Quarter of Section 17, Township 35 North, Range 9 West of the 2nd P.M., in Lake County, Indiana, except that part of Schilling Lake Add., lying North of a straight line which intersects the West line of said Northwest Quarter of the Southeast Quarter at a point 230.68 feet South of the Northwest corner of the Northwest Quarter of the Southeast Quarter and intersects the East line of said Northwest Quarter of the Southeast Quarter at a point 35.9 feet South of the Northeast corner of said Northwest Quarter of the Southeast Quarter of said Section 17, Township 35 North, Range 9 West of the 2nd P.M., all in Lake County, Indiana, as the same appears of record in Plat Book 28, page 5, in the Recorder's Office of Lake County, Indiana.
