together with all rights, privileges, interests, easements, improvements and fixtures now or hereafter located upon orappertaining to such real estate (collectively referred to as the "Mortgaged Premises"), and all leases, rents, issues, income and profits thereof, to secure the payment and all obligations of all borrowers ("Borrowers") to Mortgagee under a certain credit agreement dated 3/07/2008 , that establishes an open end line of credit for the Borrowers in the amount of \$25,000.00 with future advances, interest, and terms of payment as therein provided, or as extended, modified or renewed, executed by Borrowers to Mortgagee ("Agreement").
