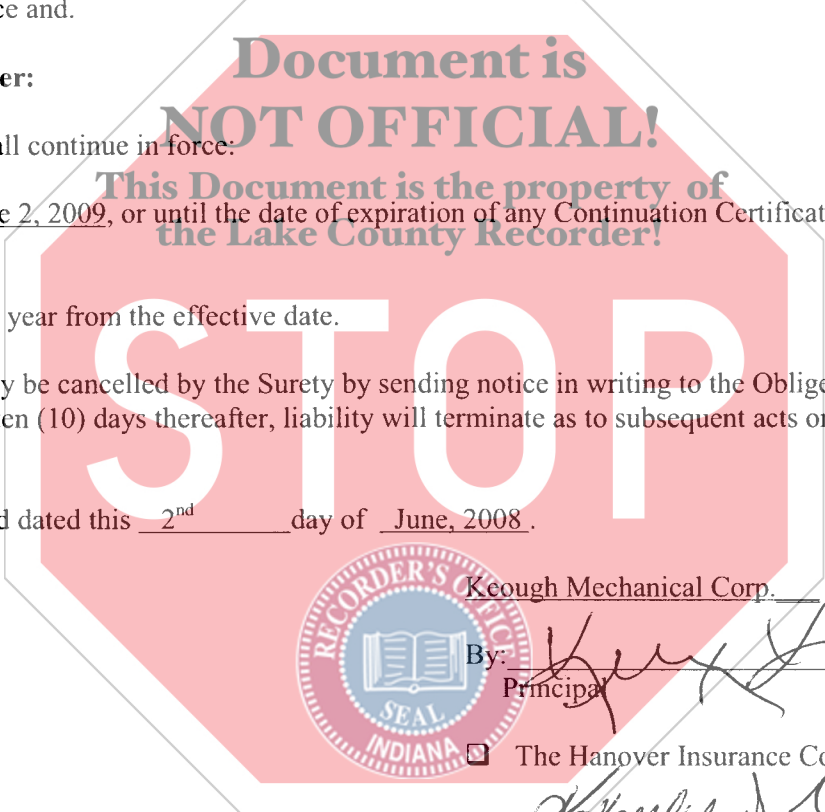
WHEREAS, the said Principal has applied to said Obligee for a license to do business as a Plumbing Contractor
