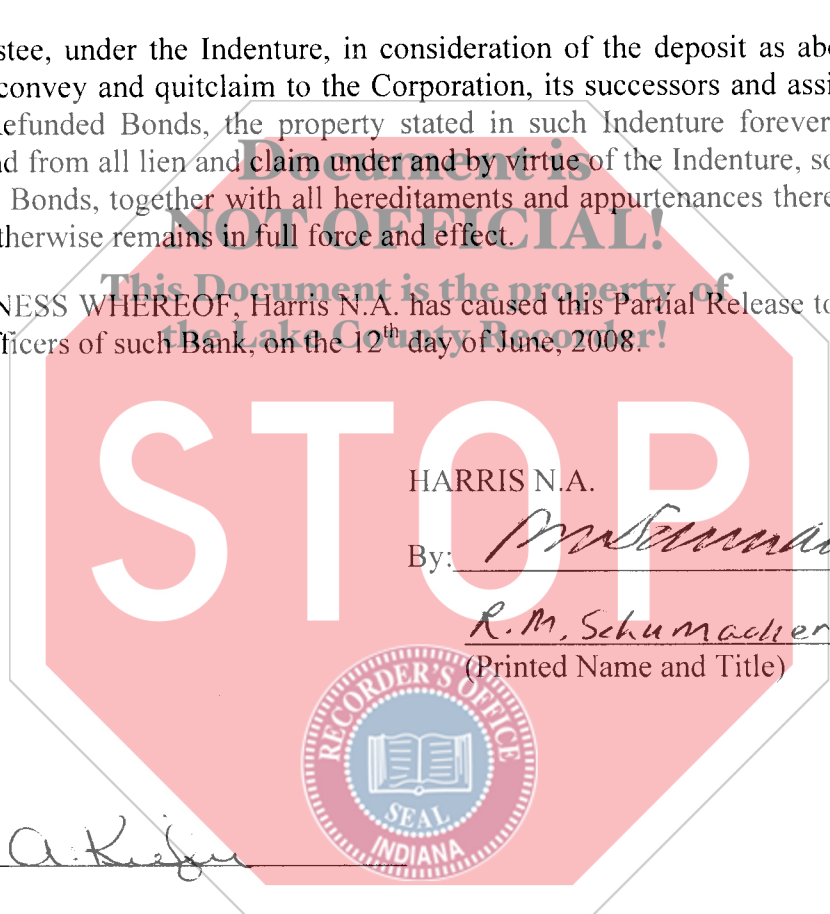

WHEREAS, Griffith Ready Elementary School Building Corporation (the "Corporation"), by a Trust Indenture dated as of dated as of September 1, 1997 and First Supplemental Trust Indenture dated as of September 1, 1999 (as supplemented, the "Indenture") for the consideration stated therein, did convey certain land and other property described on Exhibit A to Harris N.A., as successor to Mercantile National Bank of Indiana, Hammond, Indiana, as Trustee (the "Trustee"). The Trust Indenture was recorded on October 9, 1997 in the office of the Recorder of Lake County, Indiana, and appears as Instrument Number 97068684 and the First Supplemental Trust Indenture was recorded on September 1, 1999 and appears as Instrument Number 99072596;

WHEREAS, the Corporation has deposited the Trustee, securities and cash sufficient together with interest on said securities to pay the principal of and interest on all of the outstanding First Mortgage Bonds, Series 1997 dated September 1, 1997 (the "Refunded Bonds") together with fees and expenses of said Trustee, the receipt of which is hereby acknowledged; now therefore,

The Trustee, under the Indenture, in consideration of the deposit as above stated, does hereby release, convey and quitclaim to the Corporation, its successors and assigns, solely as it relates to the Refunded Bonds, the property stated in such Indenture forever free, clear and discharged of and from all lien and claim under and by virtue of the Indenture, solely as it relates to the Refunded Bonds, together with all hereditaments and appurtenances thereunto belonging. The Indenture otherwise remains in full force and effect.

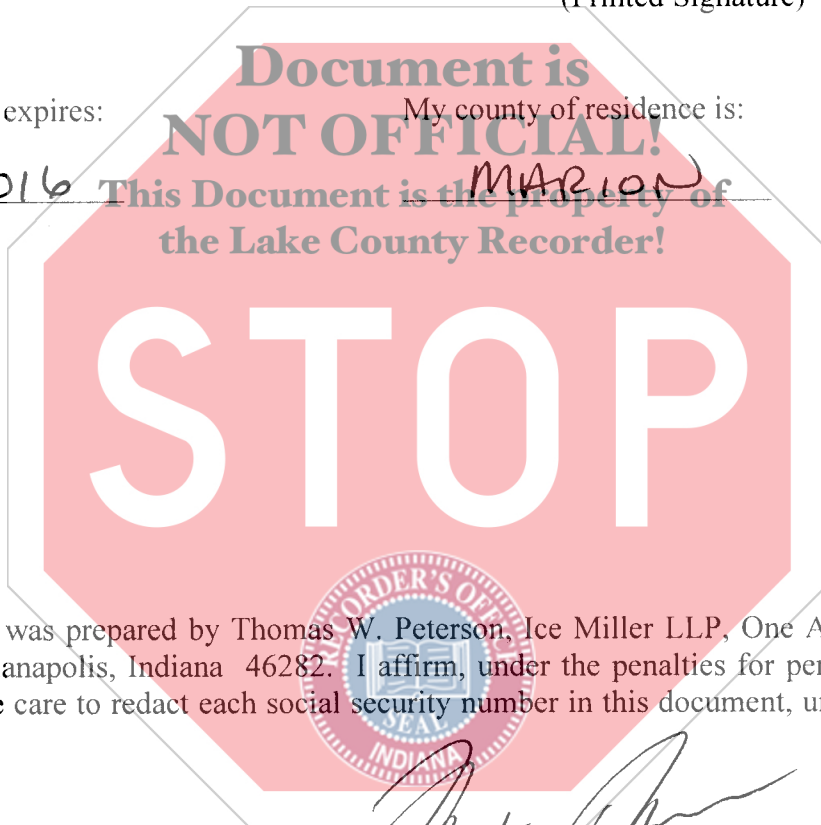

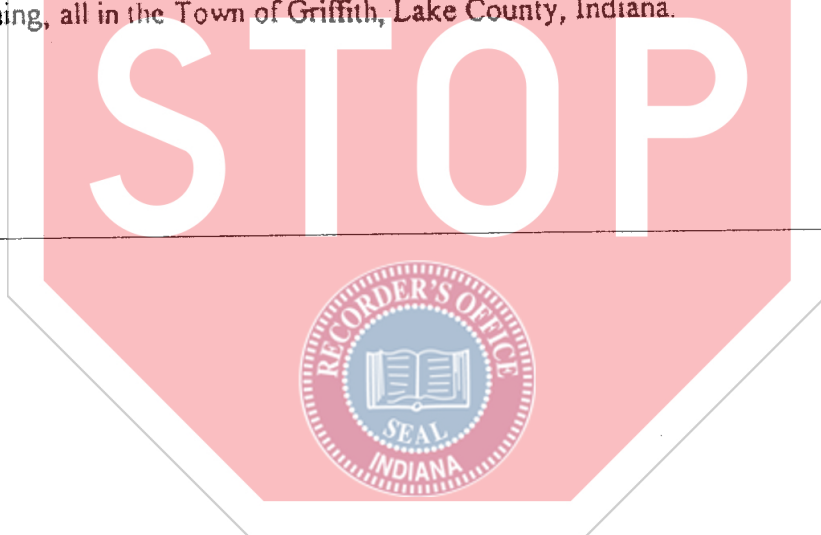

DESCRIPTION: Part of the Northwest Quarter of Section 26, Township 36 North, Range 9 West of the Second Principal Meridian in the Town of Griffith, Lake County, Indiana, being a 8 foot wide easement, which centerline is more particularly described as follows: Commencing at the intersection of the East Right-of-Way line of Broad Street and the North Right of Way line of 40th Place extended West; thence North 00° 00' 00" East, along said East Right-of-Way line, a distance of 48.67 feet, to the point of beginning of said centerline of 8 foot wide easement; thence North 90° 00' 00" East, a distance of 142.34 feet, to the point of termination of said centerline of 8 foot wide easement, all in the Town of Griffith, Lake County, Indiana.
