SHERIFF'S DEED ON DECREE

THIS INDENTURE, made this 4th day of January, A.D., 2008, between Rogelio "Roy" Dominguez, Sheriff of Lake County, in the State of Indiana, of the first part, and the FIRST MIDWEST BANK of the County of Lake and State of Indiana of the second part. WITNESSETH:

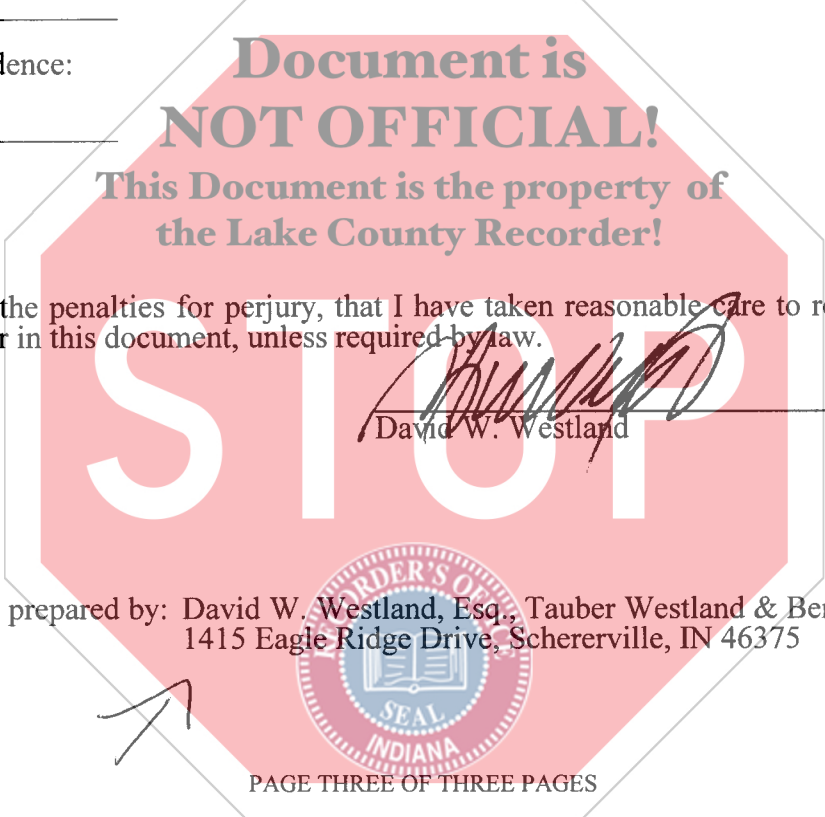
