1. That **Thomas D. Doolin** is 71 years old and the **son** of **Genevieve Doolin** and makes this affidavit based upon his own personal knowledge.

2. That by deed recorded **June 6<sup>th</sup>, 1944** as Document No. **133227** in the office of the Recorder of Lake County, Indiana, **Thomas R. Doolin and Genevieve Doolin** acquired title as **husband and wife** to the following described real estate located in **Lake County, Indiana**, to-wit:

3. That **Thomas R. Doolin** died **intestate** on the **27th day of April, 1988**, at which time **Genevieve Doolin** acquired title by survivorship affidavit recorded the **15th day of February, 1989** as Document No. **023296** in the Office of the Recorder of **Lake County, Indiana**.

4. That **Genevieve Doolin** died **intestate** on the **17<sup>th</sup> day of October, 2002**, at which time a resident of **Lake County, Indiana**, and left surviving her heirs **Thomas D. Doolin, Shawn M. Doolin, Kevin G. Doolin and Virgene C. Doolin**, leaving no other child or children or descendants of a deceased child or children surviving.

5. It appears that the decedent's gross probate estate, less liens and encumbrances, does not exceed the sum of the following: the allowance, if any, provided by IC 29-1-4-1, the costs and expenses of administration, and reasonable funeral expenses.

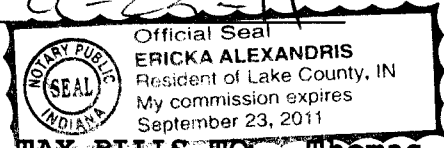
