The premises are situated in the County of **Lake**, State of **Indiana** more particularly described as follows:

Legal Description: Part of the Se ¼ of the NE ¼ of Section 4, Township 34 North, Range West of the 2nd P.M. in Lake County, Indiana, described as follows: Commencing at a brass plug in pot marking the NE corner of the NE ¼ of said Section 4; thence South 00 degrees 00' 12" West along the East line of said NE ¼ a distance of 2317.94 feet to the centerline of Beaver Dam Ditch and the Point of Beginning; thence continuing South 00 degrees 00' 12" West along the East line a distance of 379.44 feet to the SE corner of said NE ¼; thence North 89 degrees 30' 16" West along the South line of said NE ¼, a distance of 1322.93 feet to a railroad spike marking the SW corner of the East ½ of said NE ¼; thence North 00 degrees 01' 02" West along the West line of said East ½, a distance of 1052.65 feet to a 5/8" rebar with a yellow plastic cap stamped, "West-Heim Firm #0037" hereinafter referred to a rebar, said point being South 00 degrees 01' 02" East, a distance of 275 feet from the NW corner of the SE ¼ of said NE ¼; thence South 89 degrees 34' 50" East parallel with the North line of the SE ¼ of said NE ¼; distance of 270 feet to a rebar; thence North 00 degrees 01' 02" West parallel with the East line of said NE ¼, a distance of 150.00 feet to a rebar; thence South 89 degrees 34' 50" East parallel with the North line of the SE ¼ of said NE ¼, a distance of 225.53 feet to the centerline of Beaver Dam Ditch; thence South 39 degrees 03' 16" East along said centerline a distance of 299.58 feet; thence South 38 degrees 31' 20" East along said centerline a distance of 255.89 feet; thence South 43 degrees 02' 05" East along said centerline a distance of 293.52 feet; thence South 60 degrees 32' 09" East along said centerline a distance of 163.67 feet; thence South 56 degrees 34" East along said centerline a distance of 170.35 feet to the point of beginning.
