- 1. That I am an attorney admitted to practice law by the Indiana Supreme Court and hold Attorney No. 15270-49.
- 2. That I represent Tom Anderson, owner of three (3) parcels of property located in Lake County, Indiana, more commonly known at 9243 Spring Street, Highland; 3832 Missouri, Hammond; and a third parcel legally described as Part South % NE SW except R/W section 26 Township 26 Range 9 2.681 acres; all of which are more fully described in the Claim of Liens filed by Dane Jackson on or about April 2, 2008, and recorded as under Document Numbers 2008 023449; 2008 023447; and 2008 023448, respectively, in the Office of the Recorder of Lake County, in the matter of those lien claims. Pursuant to that notice, demand was made upon lien claimant to commence a suit to foreclose Claim of Liens which were filed by the lien claimant on or about April 2, 2008, 2008, under the above-stated Document Numbers in the Office of the Recorder of Lake County. A copy of said notice, return receipt card, as well as envelope are attached hereto as Exhibit "B."

- 4. That said notice advised the lien claimant of his obligation to initial lawsuit within thirty (30) days of his receipt of the notice pursuant to the provisions of Indiana Code 32-28-3-10 and 6-1 & 2.
- 5. That lien claimant has failed to file a suit to foreclose on his Claim of Liens within the statutory time aflotted. That as a result of lien claimant's failure to timely file suit, the Claim of Liens filed on or about April 2, 2008, regarding the abovedescribed properties are therefore null and void as a matter of law.
