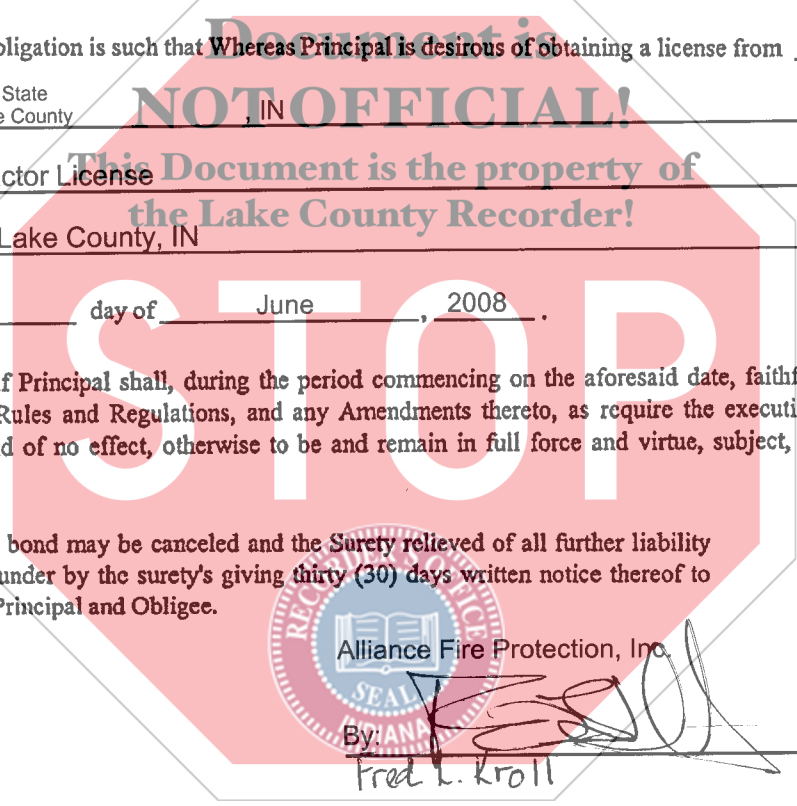

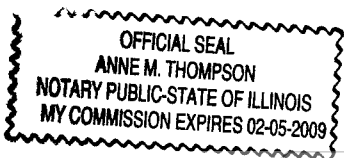

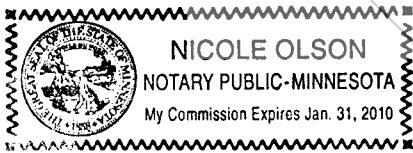

POWER OF ATTORNEY

Know All Men By These Presents:

That the Arch Insurance Company, a corporation organized and existing under the laws of the State of Missouri, having its principal office in Kansas City, Missouri (hereinafter referred to as the "Company") does hereby appoint Bruce N. Telander, R.W. Frank, John P. Martinsen, R. Scott Egginton, Donald R. Olson, John E. Tauer, Mary L. Charles, Linda K. French, Nicole Olson and Rachel Thomas of Minneapolis, MN (EACH)

its true and lawful Attorney(s)-in-Fact, to make, execute, seal, and deliver from the date of issuance of this power for and on its behalf as surety, and as its act and deed:

Any and all bonds and undertakings

EXCEPTION: NO AUTHORITY is granted to make, execute, seal and deliver bonds or undertakings that guarantee the payment or collection of any promissory note, check, draft or letter of credit.

The Company may revoke this appointment at any time.

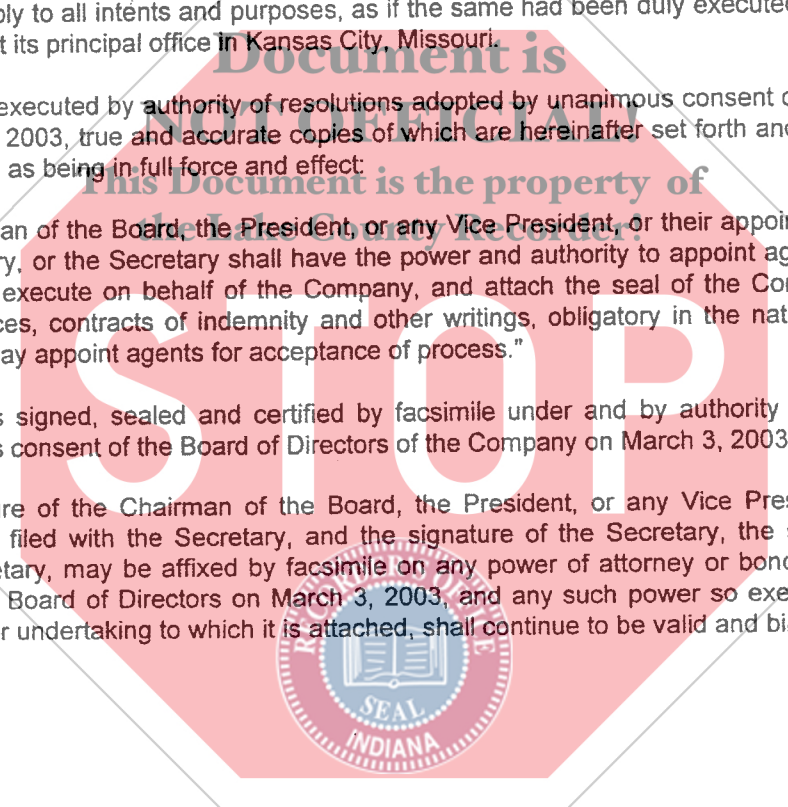
