SHERIFF'S DEED

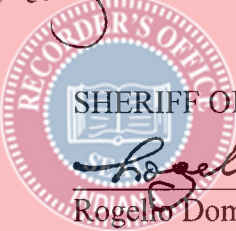
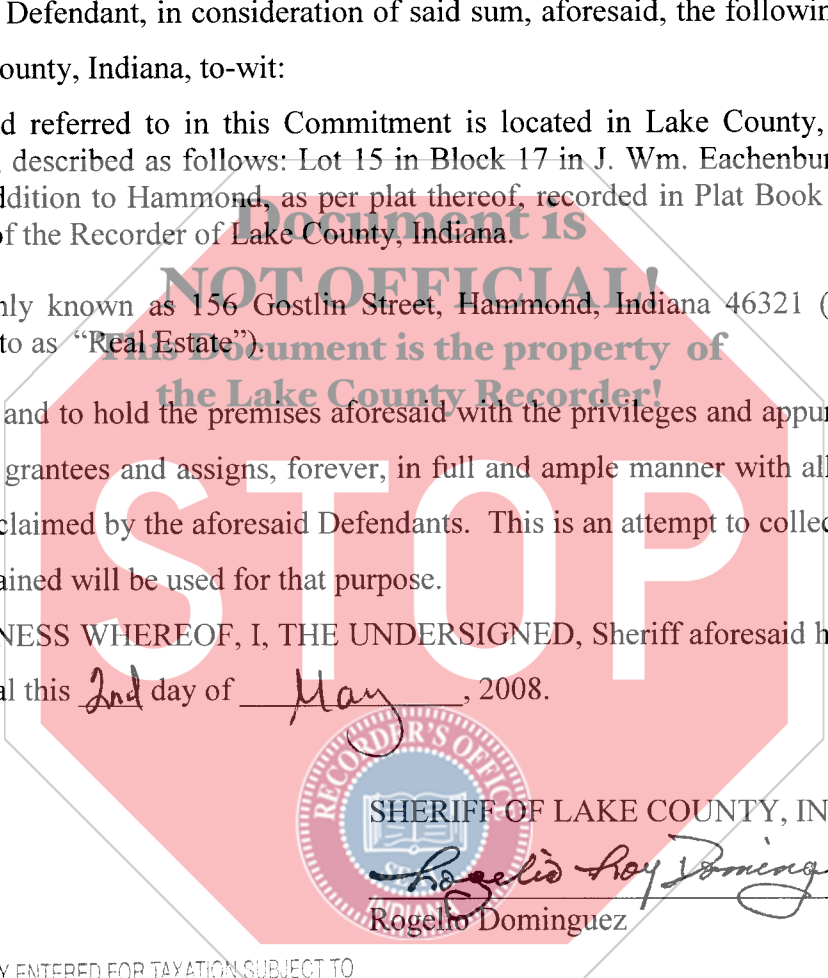
