THE CONDITION OF THE ABOVE OBLIGATION IS SUCH that whereas the said Principal has been granted a

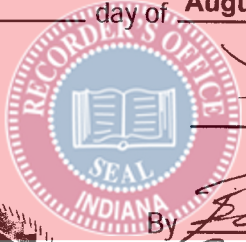
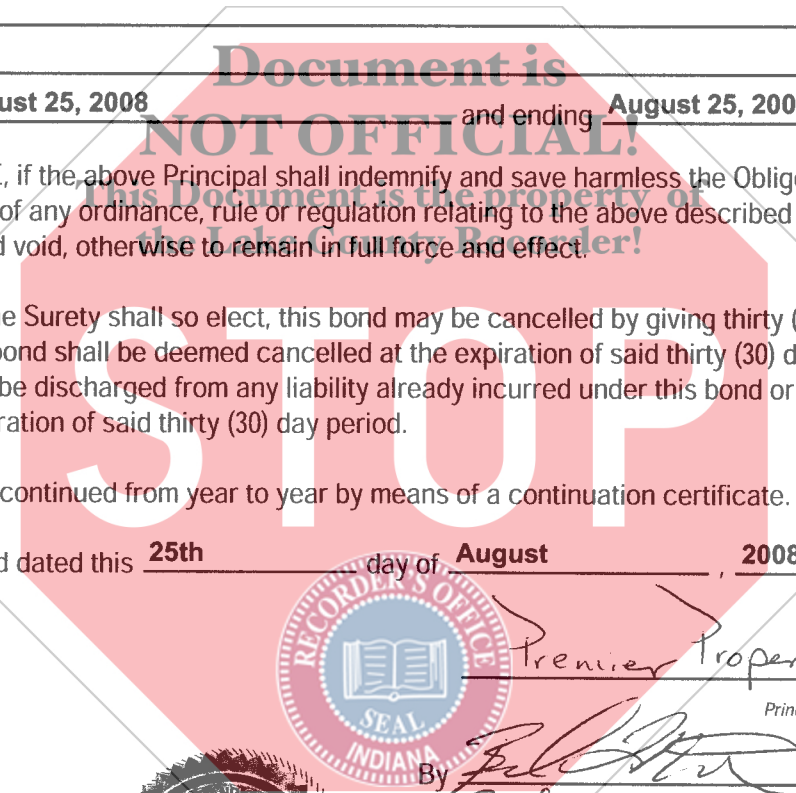
for a term beginning August 25, 2008 and ending August 25, 2009
