and the Surety shall thereupon be relieved from any liability for any acts or omissions of the Principal subsequent to said date.

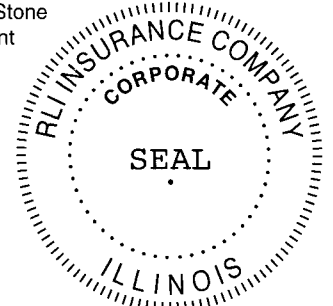
