SHERIFF'S DEED

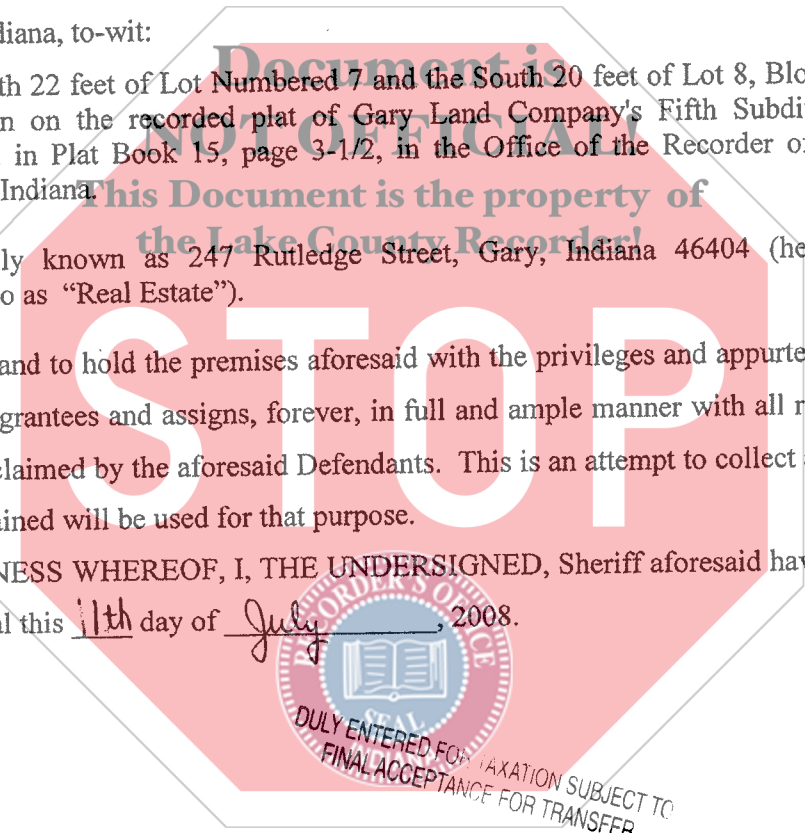

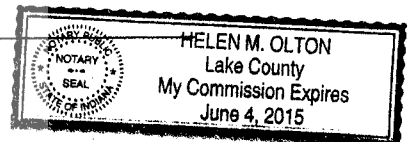
