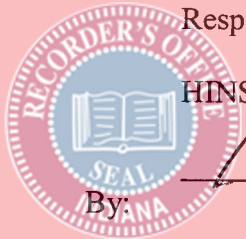
RELEASE OF LIS PENDENS NOTICE AND NOTICE OF JUDGMENT
