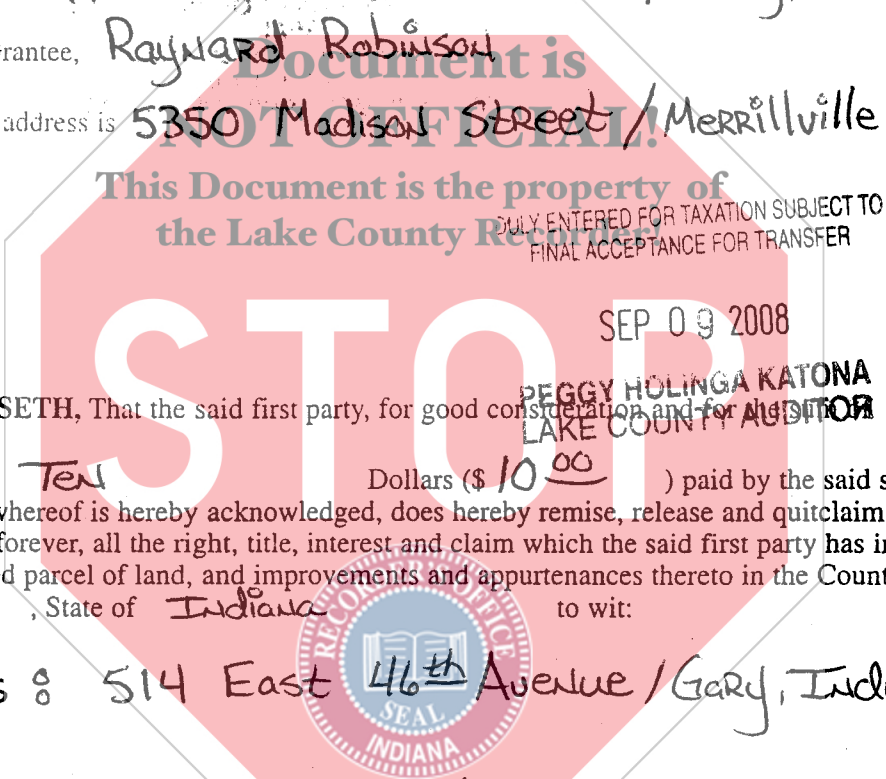


### QUITCLAIM DEED

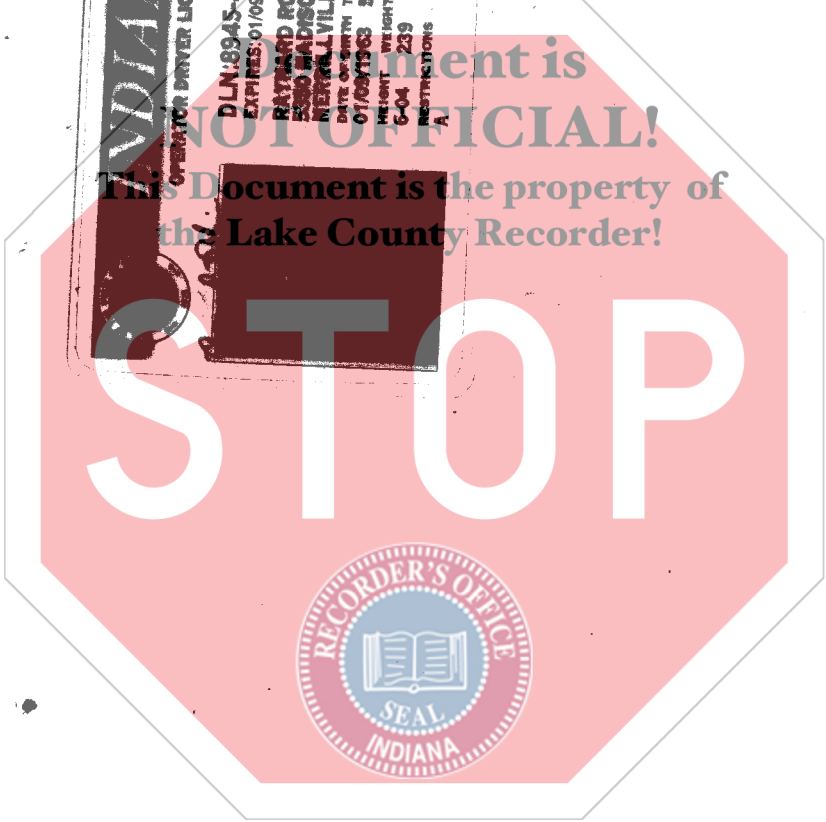
