**MEMORANDUM OF RESTATEMENT OF THE
JOAN BUCZYNSKI LIVING TRUST**

Joan Buczynski and Edmund C. Buczynski

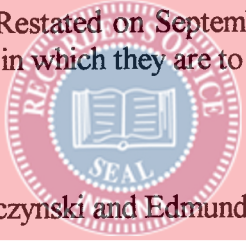
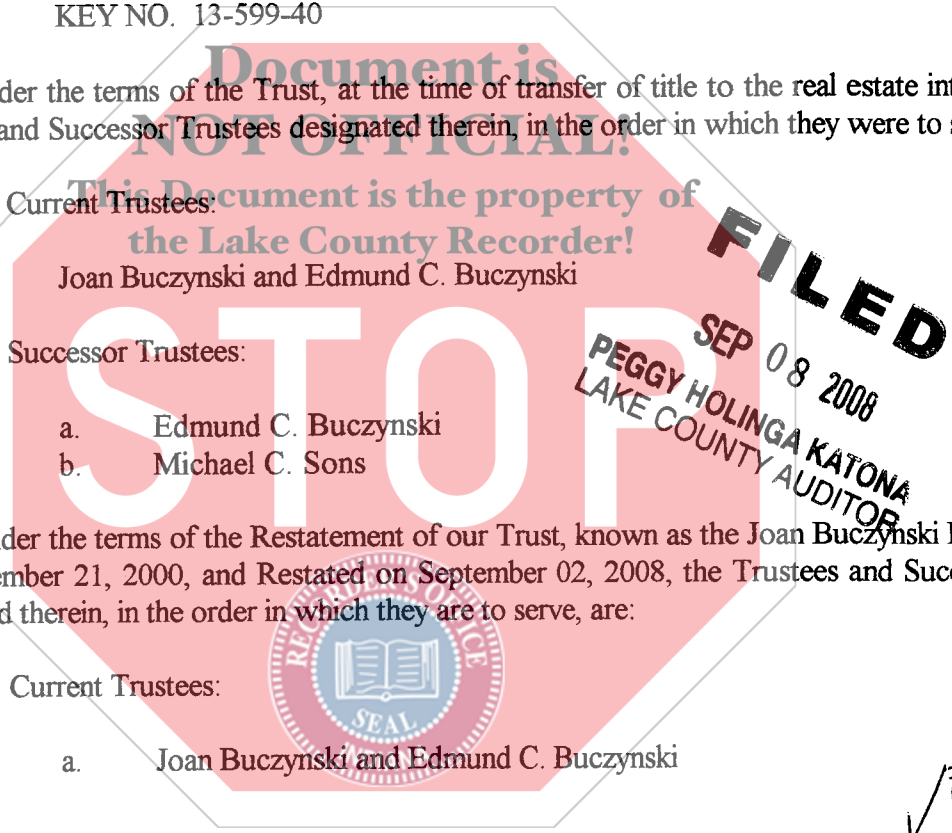
B. Successor Trustees:

B. Successor Trustees:




