**AFFIDAVIT OF SURVIVORSHIP AND MEMORANDUM OF

A. Current Trustees:

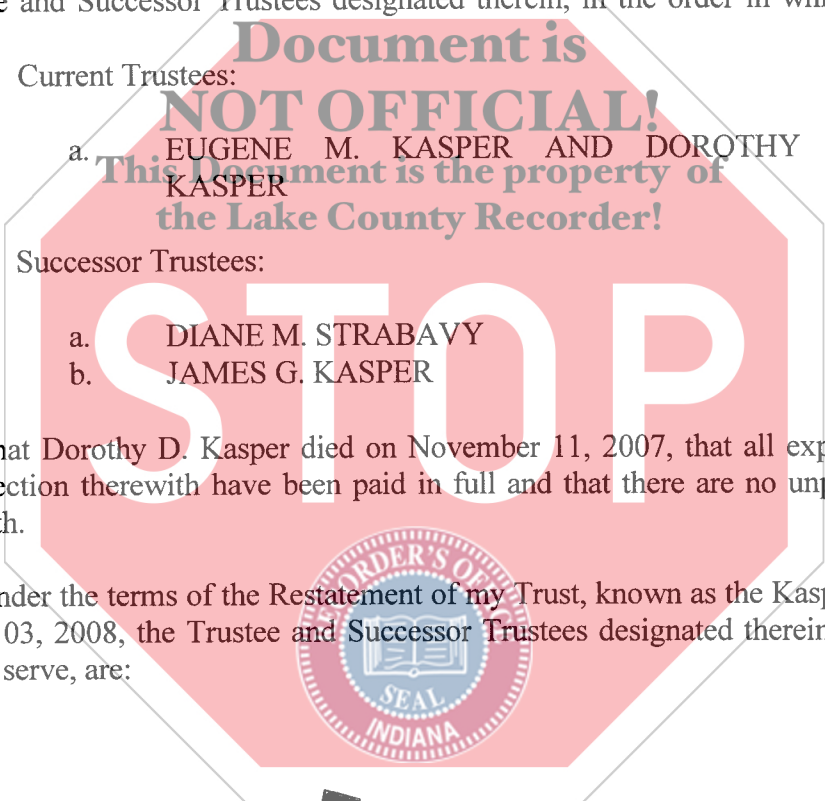
- a. EUGENE M. KASPER AND DOROTHY D. KASPER
