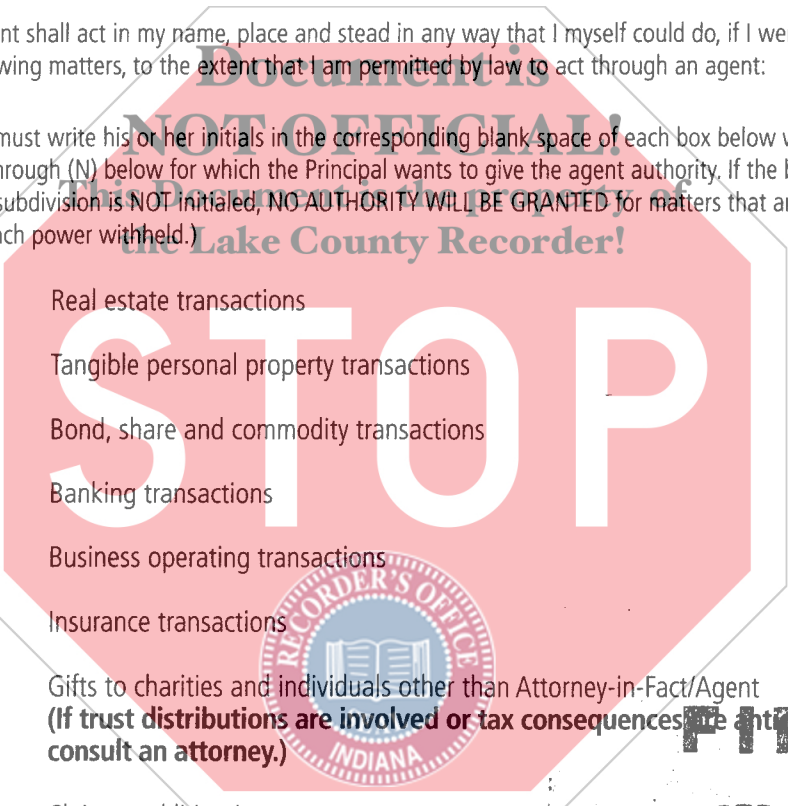
TO ALL PERSONS, be it known that I, ETHEL SEXTON

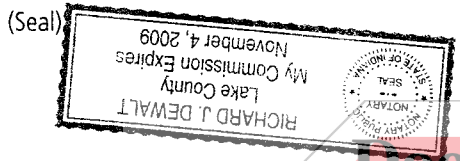
