POWER OF ATTORNEY

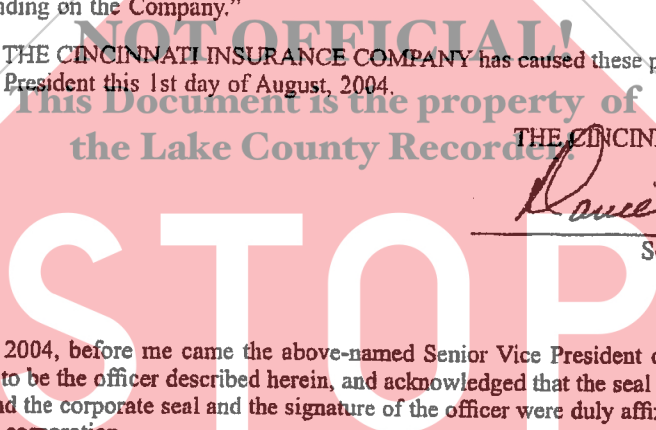

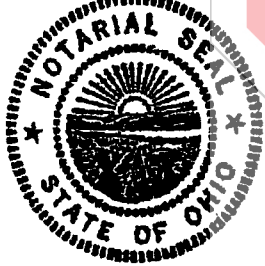
