To make and execute any and all contract pertaining to the Real Estate;

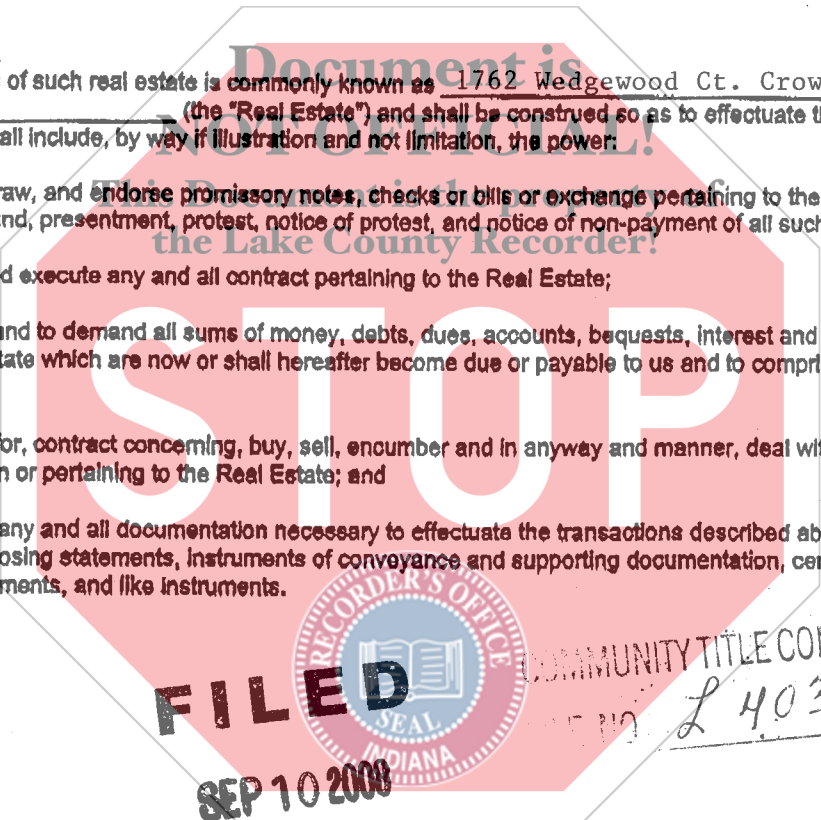
