**DEED INTO TRUST**

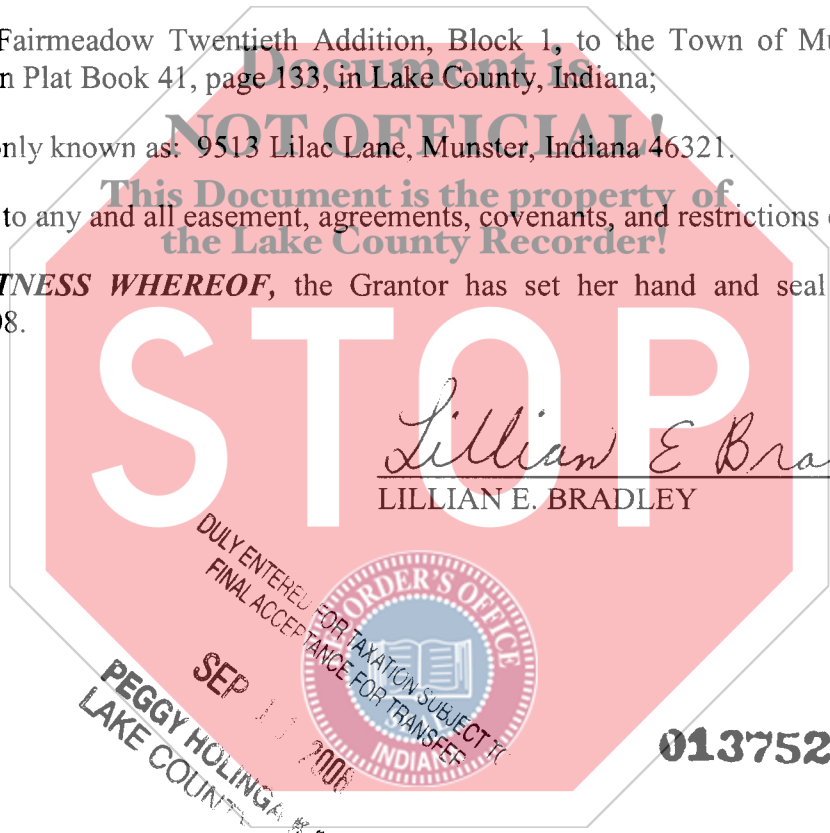
