

PARCEL 1: Part of the West Half of Section 24, Township 36 North, Range 10 West of the Second Principal Meridian in the Town of Munster, Lake County, Indiana, being more particularly described, beginning at the intersection of the South right-of-way line of Ridge Road and the West line of said Section 24, which is 1,166.01 feet, more or less, South of the Northwest corner of said Section 24; thence South 80 degrees 34 minutes 03 seconds East, along said South right-of-way line a distance of 348.07 feet; thence South 00 degrees 11 minutes 16 seconds East, along the West line of Eismin Addition to the Town of Munster as shown in Plat Book 68, Page 11 in the Office of the Recorder of Lake County, Indiana, a distance of 466.13 feet; thence North 80 degrees 45 minutes 42 seconds West, distance of 349.42 feet, to a point on the West line of said Section 24, said line also being the Indiana-Illinois State Line; thence North 00 degrees 00 minutes 00 seconds East, along previously described line, a distance of 467.07 feet, to the point of beginning, containing 3.685 acres, more or less, all in the Town of Munster, Lake County, Indiana.

The East 140 feet of that part of Lot 1 in Weinackers Subdivision of parts of Sections 29 and 32, Township 36 North, Range 15 East of the Third Principal Meridian in Cook County, Illinois, according to the plat thereof recorded June 17, 1923, as Document No. 5209264 in Book 124 of Plats, page 6, falling within the East 5 chains of Section 32 aforesaid EXCEPTING THEREFROM the following:
